

**RESOLUTION NO. 2015-02-\_\_\_ (R)**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING THE INTEREM CITY MANAGER TO REQUEST FUNDING FROM THE TEXAS DEPARTMENT OF TRANSPORTATION FOR A MASTER PLAN UPDATE FOR MCKINNEY NATIONAL AIRPORT**

**WHEREAS**, the City Council of the City of McKinney, Texas, intends to continue to develop the economic base of the City of McKinney, support economic initiatives at McKinney National Airport and increase the business of McKinney Air Center; and,

**WHEREAS**, the Current Airport Master Plan was updated using FY2003-04 data and has been used to direct the airport's successful capital development program and justify approximately \$68 million in airport improvements to-date; and,

**WHEREAS**, since the Master Plan was updated, the airport has been impacted by considerable change with regard to the City's rapid growth and development, recognition as the Number One Best Place to Live in America, completion of significant airport infrastructure projects, acquisition of the FBO facilities, the Wright Amendment Repeal, a rebounding economy, national growth in business aircraft sales and operation and plans to enhance airport access with the relocation of FM546; and,

**WHEREAS**, the City is required to maintain a current Airport Layout Plan , which is a key component of the Master Plan, on file with the Texas Department of Transportation, Division of Aviation (TxDOT-Aviation) and the Federal Aviation Administration to qualify for airport improvement grants; and,

**WHEREAS**, Airport Master Planning has historically brought elected officials, City, County and regional municipal managers and staff and regional business and community leaders together in the interest of developing a world-class business airport that supports all types of General Aviation activity: and,

**WHEREAS**, TxDOT-Aviation encourages a Master Plan Update for McKinney National Airport, which is eligible for ninety-percent (90%) funding under its programs of financial assistance to airports as well as TxDOT-Aviation's technical support for the project;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

Section 1. The City Council of the City of McKinney, Texas hereby approves conducting a Master Plan Update for McKinney National Airport.

Section 2. The City Council of the City of McKinney, Texas hereby authorizes the Interim City Manager to execute a formal funding request to the Texas Department of Transportation, Division of Aviation to conduct a Master Plan Update.

Section 3. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
