THENCE North 87 deg 59 min 00 sec East, along the Northerly line of said CLF Group tract and the Southerly right-of-way of said U.S. Highway 380, a distance of 162.28 feet to a 1/2-inch iron rod with red plastic cap stamped "W.A.L." set for corner;

THENCE South 80 deg 26 min 45 sec East, continuing along Northerly line of said CLF Group tract and the Southerly right-of-way of said U.S. Highway 380, a distance of 94.40 feet to a 1/2-inch iron rod with red plastic cap stamped "W.A.I." set for corner.

THENCE South 00 deg 32 min 52 sec East, departing the Southerly right-of-way of said U.S. Highway 380, a distance of 232.64 feet to a 1/2-inch iron rod with red plastic cap stamped "W.A.I." set for corner;

THENCE South 89 deg 27 min 08 sec West, a distance of 309.15 feet to a 1/2-inch iron rod with red plastic cap stamped "W.A.I." set for corner:

THENCE along the Easterly right-of-way of said Ridge Road and the Westerly line of said CLF Group tract, the following
