

**RESOLUTION NO. 2016-05-\_\_\_ (R)**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING THE INTERIM CITY MANAGER TO EXECUTE A CONTRACT WITH HALFF ASSOCIATES, INC. FOR PROFESSIONAL SERVICES IN ASSOCIATION WITH THE STREETScape PLAN COMPONENT OF THE PARKS, RECREATION, TRAILS & OPEN SPACE VISIONING MASTER PLAN; PROVIDING AN EFFECTIVE DATE**

**WHEREAS,** a Streetscape Plan will provide a unified design theme for the overall roadway system in the City of McKinney; and

**WHEREAS,** the City of McKinney, Texas, does not have a current Streetscape Plan in place; and

**WHEREAS,** as a result of the significant growth and imminent development of sections of the Thoroughfare Plan, the City of McKinney, Texas, wishes to create a Streetscape Plan; and

**WHEREAS,** three additional City plans are currently under review; the Parks, Recreation, Trails & Open Space Master Plan, the One Community One Vision McKinney 2040 Comprehensive Plan, and the Northwest Sector Study; and

**WHEREAS,** coordination of the Streetscape Plan with these three projects is desired; and

**WHEREAS,** City Staff and Halff Associates, Inc. have developed a Scope of Services necessary to complete the Streetscape Plan; and

**WHEREAS,** it is in the best interest of the citizens of the City of McKinney that an agreement be executed with Halff Associates, Inc. for professional services to be provided in support of the Streetscape Plan section of the Parks, Recreation, Trails & Open Space Master Plan.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

Section 1. The City Council of the City of McKinney, Texas, accepts the proposal from Halff Associates, Inc. for professional services for the Streetscape Plan section of the Parks, Recreation, Trails & Open Space Visioning Master Plan.

Section 2. The City Council of the City of McKinney, Texas, hereby authorizes the Interim City Manager to execute a professional services contract with Halff Associates, Inc. for an amount not to exceed \$30,000 for the completion of the Streetscape Plan section of the Parks, Recreation, Trails & Open Space Visioning Master Plan.

Section 3. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
