ORDINANCE NO. 2011- 07- ___

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS ESTABLISHING SPEED ZONES ON VIRGINIA PARKWAY (FM3038); AMENDING THE CODE OF ORDINACES, CITY OF MCKINNEY, TEXAS; PROVIDING FOR THE PUBLICATION OF THE CAPTION OF THIS ORDIANCE, EFFECTIVE DATE HEREOF AND A PENALTY CLAUSE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

Section 1. The Code of Ordinances, City of McKinney, Texas, Subsection 62–115, is hereby amended to read as follows:

Sec. 62-115. Virginia Parkway (FM 3038).

When no special hazard exists that requires lower speeds for compliance with this article, the speed of any vehicle not in excess of the limits in each speed zone specified in this section shall be prima facie evidence that the speed is not reasonable or prudent and that it is unlawful:

- Zone 1, which extends along FM 3038 (Virginia Parkway) from US 75 to a point 100 feet west of Jordan Road, a speed limit of 40 milesper-hour.
- Zone 2, which extends along FM 3038 (Virginia Parkway) from a point 100 feet west of Jordan road to a point 1200 feet west of Hardin Boulevard, a speed limit of 45 miles-per-hour.
- The Code of Ordinances, City of McKinney, Texas, Subsection 62-269(b), Section 2. is hereby amended to read as follows:
 - The speed limit for vehicles traveling the streets within the Slaughter Elementary School zone, as described in section 62-268(4), during the hours of 7:15 a.m. to 8:15 a.m. and 2:45 p.m. to 3:45 p.m., school days, shall be 25 miles per hour maximum.
- Section 3. The Caption of this ordinance shall be published one (1) time in a newspaper having general circulation in the City of McKinney, Texas and shall be effective immediately upon its passage and publication, and after all necessary signs have been installed.
- Section 4. Any person who violates any of the provisions of this ordinance shall be guilty of a misdemeanor and, upon conviction, shall be subject to a fine not to exceed two thousand dollars (\$2,000.00).
