

ORDINANCE NO. 2012-07-____

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS ESTABLISHING SCHOOL ZONES AT VARIOUS SCHOOLS IN MCKINNEY; AMENDING THE CODE OF ORDINANCES, CITY OF MCKINNEY, TEXAS; PROVIDING FOR PUBLICATION OF THE CAPTION OF THE ORDINANCE, EFFECTIVE DATE HEREOF AND A PENALTY CLAUSE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

Section 1. The City Council of the City of McKinney, Texas hereby amends the Code of Ordinances by adding a section in Chapter 62, Article V, to be numbered 62 – 344, which will read as follows:

Sec 62-344. Comstock Elementary School – Zone Designated.

The Comstock Elementary School zone shall be:

- (1) On Silverado Trail beginning at the western Comstock Elementary School property line and extending eastward to a point 250 feet east of the eastern Comstock Elementary School property line.
- (2) On Blue Moon Drive beginning at Silverado Trail and extending northward to Denali Drive.
- (3) On Denali Drive beginning at Mendocino Trail and extending eastward to Blue Moon Drive.
- (4) On Mendocino Trail beginning at Denali Drive and extending northward to Grand Mesa Parkway.
- (5) On Grand Mesa Parkway beginning at a point 200 feet west of the western Comstock Elementary School property line and extending eastward to Mendocino Trail.

Section 2. The City Council of the City of McKinney, Texas hereby amends the Code of Ordinances by adding a section in Chapter 62, Article V, to be numbered 62 – 344.1, which will read as follows:

Sec 62-344.1 Same – Speed.

The speed limit for the vehicles traveling the streets within the Comstock Elementary School zone during the hours of 7:05 a.m. to 8:05 p.m. and 2:35 p.m. to 3:35 p.m., school days, shall be 20 miles per hour maximum.

Section 3. The City Council of the City of McKinney, Texas hereby amends the Code of Ordinances by adding a section in Chapter 62, Article V, to be numbered 62 – 344.2, which will read as follows:

Sec 62-344.2 Same – Crosswalks.

Crosswalks shall be established at the Comstock Elementary School zone as follows:

- (1) On Silverado Trail along the west side of the intersection with Alfalfa Drive.

Section 4. The City Council of the City of McKinney, Texas hereby rescinds Section 62-337 (3) of the Code of Ordinances.

Section 5. The City Council of the City of McKinney, Texas hereby rescinds Section 62-339 (3) of the Code of Ordinances.

Section 6. The City Council of the City of McKinney, Texas hereby amends Section 62 – 332 of the Code of Ordinances by adding a subsection (3), which will read as follows:

(3) On Westridge Boulevard beginning at a point 300 feet west of Eden Drive and extending eastward to a point 300 feet east of Eden Drive.

Section 7. The City Council of the City of McKinney, Texas hereby amends Section 62 – 334 of the Code of Ordinances by adding a subsection (2), which will read as follows:

(2) On Westridge Boulevard along the east side of the intersection with Eden Drive.

Section 8. The City Council of the City of McKinney, Texas hereby amends Section 62 – 310 (1) of the Code of Ordinances, which will read as follows:

(1) On Joplin Drive beginning at a point 10 feet south of the southern Minshew Elementary property line and extending northward to a point 225 feet south of Lea Drive.

Section 9. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, after all the necessary signs and markings have been installed, and it is accordingly so ordained.

Section 10. Any person who violates any provisions of this Ordinance shall be guilty of a misdemeanor and, upon conviction, shall be subject to a fine not to exceed two thousand dollars (\$2000).
