

## **CITY COUNCIL REGULAR MEETING**

**FEBRUARY 7, 2023**

The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, February 7, 2023 at 6:00 p.m.

The meeting was broadcast live on cable television and through the City's website on Spectrum Channel 16; AT&T U-Verse Channel 99; and <https://mckinneytx.new.swagit.com/views/130>. The video recording of the meeting is available to the public through the City of McKinney video archive.

Mayor George C. Fuller called the meeting to order at 6:11 p.m. upon determining a quorum consisting of himself and the following City Council Members were present: Council Members Justin Beller, Geré Feltus, Rick Franklin, Charlie Philips, and Patrick Cloutier.

Mayor Pro Tem Rainey Rogers was absent.

Council unanimously approved the motion by Mayor George Fuller, seconded by Council Member Geré Feltus, to table agenda items 23-0058 and 23-0059 until the City Council Regular Meeting of February 21, 2023.

Mayor Fuller called for Council and Manager Comments.

Council Member Beller commended Council Member Feltus for her efforts coordinating the McKinney Black History Month program, which started with an event including the "Grandmother of Juneteenth" Opal Lee. Council Member Beller stated he was looking forward to the other activities including the 1970's theme Soul Train event.

Council Member Patrick Cloutier thanked Council Member Feltus and made positive remarks on the Opal Lee event, including that when she was a child, her home was set afire on Juneteenth, yet she has continued to demonstrate kindness throughout her life and work.

Council Member Charlie Philips stated the McKinney North High School Girls Varsity Basketball team is currently undefeated in district play and noted the standout of play of Kaelyn Hamilton (averaging 18 points per game) and Ciara Harris (averaging 15 points per game). Council Member Philips encouraged everyone to support the team by attending their games.

Council Member Geré Feltus thanked Mayor Fuller and Council Members Beller and Cloutier for attending the Black History Month event featuring Opal Lee. Council Member

Feltus attended the recent memorial service for Amanda Kelly who was an art teacher at Valley Creek Elementary in McKinney and also taught Council Member Feltus' daughters at the school. Council Member Feltus stated the service was well-attended and reflective of Ms. Kelly's legacy and impact on those she taught. Council Member Feltus thanked the Public Works, Public Safety, and Hospital staff, expressing appreciation for their work to keep people safe and healthy during the recent severe weather storms.

City Manager Paul Grimes made these announcements:

- The city recognizes active-duty military members through the Blue Stag Flag program. Applications are available on the city website and service members will publicly be recognized at a City Council members.
- The City Council will participate in a Strategic Goals Work Session on Friday, February 17 at 8:00 a.m. The half-day event is open to the public and will be held in Council Chambers.
- The City Council will meet in Joint Session with the McKinney Independent School District (MISD) Board of Trustees on Monday, February 27. The 6:00 p.m. Joint Meeting will be held at the MISD Stadium Community Event Center.

Mayor Fuller remarked on the Black History Month activities and memorial service for Amanda Kelly. Mayor Fuller stated a music scholarship has been established in honor of his friend and guitarist Jim McCandless who passed away after battling cancer. The scholarship will assist students with music training.

Council unanimously approved the motion by Council Member Patrick Cloutier, seconded by Council Member Geré Feltus, to adjourn the meeting at 7:27 p.m.
