

RESOLUTION NO. 2021-08-091 (R)

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, APPROVING THE COMMUNITY DEVELOPMENT BLOCK GRANT FY2022 (PY21) ANNUAL ACTION PLAN UNDER THE 2020-2024 CONSOLIDATED PLAN, AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City Council authorizes the City Manager or Designee, to make application for, accept and administer Community Development Block Grant Funds (CDBG); and

WHEREAS, the U.S. Department of Housing and Urban Development will review and accept the Annual Action Plan providing CDBG funds for the 2021-2022 fiscal year to begin October 1, 2021; and

WHEREAS, the Community Grants Advisory Commission held two public hearings and prepared recommendations for Council acceptance of the Plan under the use of FY2022 Community Development Block Grant Funds, and amendments of previous CDBG and CDBG-CV funding to continue to prevent, prepare and respond to the spread of Coronavirus disease (COVID-19); and

WHEREAS, activities under the Annual Action Plan include public services recommendations, housing and community development and grant administration; and

WHEREAS, the U.S. Department of Housing and Urban Development will review and give final approval of the FY2022 (PY21) Annual Action Plan.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:
