Please accept this letter as evidence of our intent to file a site plan for one lot on the east side of Lake Forest Drive, approximately 1,300 feet south of U.S. Highway 380.

The site consists of 1.4405± acres of land in the Craig Children's Trust addition to the City of McKinney with an existing D-1 (undeveloped land) zoning.

The proposed building is to be a medical clinic use. The area of the building is to be approximately 8,600 square feet. There is a creek running along the eastern edge of the property. The proposed building is currently shown to be within the 100-year flood plain boundary, but it is our understanding that recently completed construction in the area has modified the creek such that the proposed flood plain has been shifted away from the proposed building's location. We are awaiting official approval from the City and from FEMA to update the flood plain on our plans.

We understand that this site plan will be handled as a staff approval item. We look forward to working with the City staff toward the successful completion of our project.

Please accept this letter as evidence of our intent to file a revised landscape plan request for one lot on the east side of Lake Forest Drive, approximately 1,300 feet south of U.S. Highway 380.
