10-515 Mayor Loughmiller called for Discussion on an Upcoming Rezoning Request (10-115Z) for the Adriatica Development Mayor Loughmiller stated that this item was originally linked to agenda item 10-098Z which the developer subsequently withdrew to allow time to make modifications. The zoning item will be considered by the Planning & Commission at their November 9th meeting. recommendation will be forwarded to the November 16th City Council meeting. Planning Director Jennifer Cox stated that Jeff Blackard removed the addition of multi-family dwellings and increased building heights in the Town Center of Adriatica. The applicant is requesting the following modifications: provision for five directional signs within the Adriatica Development; allowance of vertical mixed uses along the Stonebridge Drive frontage; modification of a timing mechanism that requires 40,000 square feet of commercial uses to be constructed concurrently with the first 50 residential units within the Town Center, allowing that commercial to be free standing or vertically integrated; modification to allow 13 rather than 30 dwelling units in the Villa District to be built prior to building residential units in the Town Center; allowance of a Farmers Market within the Town Center; allowing for 2 pedestrian bridges over right-of-ways; and that certain provisions of the Zoning Ordinance in regards to screening devices, landscape buffers, parking area screening, and height restrictions for multi-family do not apply to the subject property. Mayor Loughmiller confirmed that they currently have constructed 13 dwellings in the Villa District and would be able to begin

residential unit construction now in the Town Center.

10-098Z Mayor Loughmiller stated that this item has been withdrawn and no public hearing or action will be necessary. Public Hearing for Consideration/Discussion/Action on the Request by SB Harbor Market, J.V., for Approval of a Request to Rezone Approximately 35.15 Acres from "PD" - Planned Development District to "PD" - Planned Development District, Generally to Modify the Development Standards, Located on the Southeast Corner of Virginia Parkway and Stonebridge Drive. THIS ITEM HAS BEEN WITHDRAWN. NO FURTHER ACTION IS

10-063A2 Mayor Loughmiller called for Public Hearing for Consideration/Discussion on the Request by Petsche and Associates, Inc., on Behalf of Blue Star Land L.P., on a Petition to Annex Approximately 238.92 Acres, Located on the Southeast Corner of U.S. Highway 380 (University Drive) and Coit Road. Executive Director of Development Services John Kessel stated that this is the second public hearing for a request to annex 238 acres of land at the corner of US 380 and Coit Road. Mr. Kessel stated that annexation is the easiest way for the City to control zoning. The associated zoning of this land will be presented at the December 7th meeting. Highlights discussed about the site were the inclusion of an Prosper Independent School District elementary school site, a 3 acre park, 20 acres of open space and a tie into the hike and bike trail. The plans have a slightly larger home provision for homes up to approximately 4,000 square feet. Mr. Kessel stated that at build out this development will have a conservation revenue estimate of \$1,000,000.00 for the City. Mr. Kessel stated that Staff is looking at this project not just from a quality standpoint, but also a quantity. Staff feels that the positives of this development outweigh the negatives. The third public hearing is scheduled for December 7th. Applicant, Mr. Pete Petsche stated that the standards for this

development are under Ordinance 1621. There are to be 575 single family unit homes with the 50 foot lots that will sell for \$170,000-\$220,000 and the 60 foot lots will sell in the \$200,000-\$280,000 price range. Mr. Kessel stated that Fire Station 7 already services the area. Mayor Loughmiller called for public comment and there was none. Council unanimously approved the motion by Mayor Pro-Tem Huff, seconded by Council member Ussery, to close the public hearing.

Mayor Loughmiller called for a Public Hearing to Consider/Discuss/Act on the Request by O'Reilly Automotive, Inc., for Approval of a Specific Use Permit and Site Plan for an Indoor Automotive Parts Sales Building (O'Reilly Auto Parts), Approximately 0.78 Acres, Located on the West Side of Custer Road and Approximately 900 Feet North of Virginia Planning Director Jennifer Cox stated that Staff is Parkway. recommending denial of O'Reilly Auto Parts' request for a specific use permit and site plan for an indoor automotive parts sales. concerns were the noise to the neighborhood and people working on cars in the parking lot. Applicant Ken Paxton, 5613 Woodstock Circle, McKinney stated that it is O'Reilly's policy to prohibit working on cars in the parking lot of their stores. Mr. Paxton stated that there will be no additional noise from the store. Civil Engineer Paul Ingall stated that 50% of their store sales are delivery to mechanics and auto repair businesses. Mr. Ingall stated that there will be an 8 foot masonry screening wall built and it will be put up prior to any of the other construction to further shield the neighbors. Mayor Loughmiller called for public comment and there was none. Council unanimously approved the motion by Council member Ray Ricchi, seconded by Council member Pete Huff, to close the public hearing and approve the specific use permit and site plan that will be ratified by Ordinance on November 16, 2010 with the following conditions: Use and development of the subject property (0.78 acre) shall conform to the following regulations: The subject property shall develop in accordance with Ordinance Nos. 2006-04-039, 2004-11-116, 2004-01-006, and 98-08-44, except as follows: the subject property shall generally develop in accordance with the site plan, landscape plan, and building elevations; an eight-foot (8') masonry screening wall of a uniform screening type and neutral color, matching the existing screening wall adjacent to the subject property on its south side, shall be provided along the north and west property lines where adjacent to single family residential uses; Mechanical or repair work shall be prohibited on the subject property; hours of operation shall be limited to Monday through Friday 8 a.m. to 8 p.m. and Saturday through Sunday 8 a.m. to 6 p.m.

Mayor Loughmiller called for Council and Manager Comments and Liaison Reports.

Council member Brooks reminded everyone that the Veteran's Day Ceremony is scheduled for November 13th at 11 a.m. at Craig Ranch. "This time next year we will be having our inaugural Veteran's Day Ceremony at the completed Veteran's Memorial Park."

Council member Ussery stated that the Housing Authority met on October 26th and elected Alonzo Tutson as their new Chairman. The Planning and Zoning Commission met on October 26th and approved two applications and tabled one for a later date. Mr. Ussery thanked staff for all that they do.

Mayor Pro-Tem Huff stated that he represented the Council at the Boys & Girls Club celebration of the after school program. The Boys & Girls Club had their Chrysalis Ball, which is their big fundraiser for the year. The McKinney Community Development Corporation met Thursday, October 28th with their three new members joining the board. Tracy Rath was elected Chairman, George Fuller, Vice Chairman, and Dan Hall Secretary. The Flour Mill project was discussed in detail from a legal, business development, MCDC, and City view points and it was denied.

Council member Ricchi stated that the McKinney Convention and Visitors Bureau met and decided that they were going to send members to the other board meetings to

keep informed. They are encouraging local hotels to participate in promoting tourism for the City. They are also going to hold their meetings at local hotels instead of at the tourism office. Downtown was rocking on October 29th with the performance of the Rocky Horror Picture Show. Mr. Ricchi stated that US Representatives Sam Johnson and Ralph Hall along with General Harvey McCarter and Mayor Brian Loughmiller will be speaking at the Veterans Memorial Day event.

Council member Day stated that Scare on the Square that was held on October 29th was a success with several thousand kids in costumes trick or treating around the downtown square. Downtown McKinney continues to get good press with a travel writer posting a new article in a San Antonio Magazine extolling the virtues of Downtown McKinney.

Council member Kever thanked City Secretary Sandy Hart for the Oath's of office she has given to the various new Board and Commission members over the last month. The Community Grants Advisory Board elected Aaron McMahon as their Chairman. The Board reviewed 24 grant applications totaling \$647,000.00. The board has \$120,000.00 available to award and will be deciding how they will award the grant The Library has an amnesty program going on to forgive any fines owed to money. the library between now and November 15th. Mr. Kevin Magavern was elected the new Chairman of the Library Board. The McKinney Arts Commission elected Nicole Bedford as the new chairman and they will be meeting on November 4th to discuss a public arts policy. Ms. Kever attended the Dallas Regional Mobility Commission meeting where they discussed proposals for the 82nd session legislative agenda. Texas Transportation Institute said that if we do nothing, the cost to Texas will be the loss of 288,000 jobs by 2035. They stated that proper maintenance can extend the life of a roadway by 18 years. Traffic delays will cost \$3,300 per person by 2035 with 140 hours spent in traffic by the average commuter, compared to the 38 spent today. Ms. Kever attended the Texas A&M ballgame at Kyle Stadium and was proud of McKinney's own, Jeff Fuller, who graduated from McKinney Boyd. He is a standout player with 11 catches and 2 touchdowns on Saturday's game.

Mayor Loughmiller thanked Mayor Pro-Tem Huff and Council memember Ricchi for attending the Chrysalis Ball and representing the City. The Mayor has had a busy 8

days and spent Saturday attending his son's band competition. Mayor Loughmiller

spoke to the Voyagers group, giving him a great opportunity to give insight on what the

City's plans are and how we are moving McKinney forward. The City Council had a

joint meeting with the McKinney Independent School District Board of Trustees on

Monday and discussed issues from a budgetary standpoint, communication goals,

collaboration, and future meetings. The City Council's November 29th work session will

be focused on ordinance revisions, annexation policy, density issues, building heights,

and ways to encourage commercial development for the next 10-20 years. The Mayor

thanked staff for all they do to make McKinney the Best Place to Live.

Interim City Manager Chaffin stated that there are approximately 20 future work

session agenda items that will be scheduled over the next several months. Mr. Chaffin

stated that he has provided the Council with the Mission/Vision/Goals that were talked

about at the retreat. Mr. Chaffin requested their comments, corrections and/or additions

so that they can be incorporated. Mr. Chaffin thanked Mr. Kessel for attending tonight's

meeting since he has been out of the office recovering from surgery.

Mayor Loughmiller called for Citizen Comments and there were none.

Council unanimously approved the motion by Mayor Pro-Tem Pete Huff,

seconded by Council member Ussery, to adjourn. Mayor Loughmiller adjourned the

meeting at 8:12 p.m.
