A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, REVISING AND RESTATING RESOLUTION 2012-04-049(R) ESTABLISHING SCHOOL ZONE HOURS FOR EACH SCHOOL HOLDING SUMMER SCHOOL IN 2012

- **WHEREAS**, the City Council of the City of McKinney, Texas, has approved an Ordinance establishing school zones for schools holding summer school; and
- WHEREAS, on April 17, 2012, the City Council passed and approved Resolution 2012-04-049(R) establishing the school zone hours for each school holding summer school in 2012; and
- WHEREAS, McKinney ISD staff has requested a revision to the times and dates for the Lawson Early Childhood Center summer session, leaving the other school summer sessions unchanged; and
- **WHEREAS**, summer school dates and time have been determined by McKinney Independent School District for 2012.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

- Section 1. The City Council of the City of McKinney, Texas hereby establishes school zone hours for Boyd High School during the hours of 6:45 a.m. to 7:45 a.m. and 11:15 a.m. to 12:15 p.m. on summer school days beginning June 12, 2012 and ending August 2, 2012.
- Section 1. The City Council of the City of McKinney, Texas hereby establishes school zone hours for Cockrill Middle School during the hours of 7:45 a.m. to 8:45 a.m. and 12:15 p.m. to 1:15 p.m. on summer school days beginning June 11, 2012 and ending July 26, 2012.
- Section 3. The City Council of the City of McKinney, Texas hereby establishes school zone hours for Malvern Elementary School during the hours of 7:45 a.m. to 8:45 a.m. and 2:15 p.m. to 3:15 p.m. on summer school days beginning June 11, 2012 and ending July 26, 2012.
- Section 4. The City Council of the City of McKinney, Texas hereby establishes school zone hours for Slaughter Elementary School during the hours of 6:45 a.m. to 7:45 a.m. and 2:45 p.m. to 3:45 p.m. on summer school days beginning June 6, 2012 and ending June 29, 2012.
- Section 5. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
