

CITY COUNCIL WORK SESSION

NOVEMBER 3, 2020

The City Council of the City of McKinney, Texas met in work session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas on Tuesday, November 3, 2020, at 4:00 p.m.

Mayor Fuller called the meeting to order at 4:03 p.m. upon determining a quorum of the City Council was present.

Mayor Fuller called for public comments on agenda items. There were none.

Mayor Fuller called for the discussion of the agenda items to be presented at the City Council Regular Meeting of Tuesday, November 3, 2020, at 6:00 p.m.

Director of Planning Jennifer Arnold spoke regarding agenda items # 20-0114Z2 (Conduct a Public Hearing to Consider/Discuss/Act on a Request to Rezone the Subject Property from “PD” – Planned Development District and “TMN” - Traditional McKinney Neighborhood Overlay District to “PD” – Planned Development District and “TMN” - Traditional McKinney Neighborhood Overlay District, to Allow an Emergency Overnight Warming Station, Located on the North Side of Wilson Creek Parkway and Approximately 850 Feet West of College Street; and Accompanying Ordinance) and #20-0004SUP2 (Conduct a Public Hearing to Consider/Discuss/Act a Specific Use Permit Request to Allow for Garage, Auto Repair Facility (Express Oil Change & Tire Engineers), Located on the East Side of Hardin Boulevard and Approximately 1,500 Feet South of U.S. Highway 380 (University Drive), And Accompanying Ordinance).

Mayor Pro Tem Rogers updated the Council on Main Street activities this holiday season.

Council Member Shemwell updated the Council on the Urban Transit District Board and the services that the Board is providing.

Council Member Franklin updated the Council on the Planning and Zoning Commission.

Council Member Frazier updated the Council on the McKinney Community Development Corporation (MCDC) and the goals that they set for 2021. Council

Member Frazier thanked MCDC President Cindy Schneible for all the work she has done.

Mayor Fuller updated the Council on the McKinney Economic Development Corporation (MEDC). Brian Loughmiller was voted in as the Chairman and Michael Jones as Vice Chairman for MEDC.
