## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, ESTABLISHING SCHOOL ZONE HOURS FOR EACH SCHOOL HOLDING SUMMER SCHOOL IN 2013

- Section 1. The City Council of the City of McKinney, Texas hereby establishes school zone hours for McKinney North High School Session 1 during the hours of 6:45 a.m. to 7:45 a.m. and 12:15 p.m. to 1:15 p.m. on summer school days beginning June 12, 2013 and ending July 30, 2013.
- Section 2. The City Council of the City of McKinney, Texas hereby establishes school zone hours for McKinney North High School Session 2 during the hours of 6:45 a.m. to 7:45 a.m. and 2:15 p.m. to 3:15 p.m. on summer school days beginning July 15, 2013 and ending July 30, 2013.
- Section 3. The City Council of the City of McKinney, Texas hereby approves the use of the When Flashing sign for the McKinney North High School summer session as the Texas Manual on Uniform Traffic Control Devices allows.
- Section 4. The City Council of the City of McKinney, Texas hereby establishes school zone hours for Scott Johnson Middle School during the hours of 7:45 a.m. to 8:45 a.m. and 12:15 p.m. to 1:15 p.m. on summer school days beginning June 12, 2013 and ending June 27, 2013.
- Section 5. The City Council of the City of McKinney, Texas hereby establishes school zone hours for Malvern Elementary School during the hours of 7:15 a.m. to 8:15 a.m. and 2:15 p.m. to 3:15 p.m. on summer school days beginning June 12, 2013 and ending July 25, 2013.
- Section 6. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
