

**RESOLUTION NO. 2015-10-\_\_\_\_ (R)**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, COLLIN COUNTY, TEXAS, AUTHORIZING INTERIM CITY MANAGER TO MAKE APPLICATION TO THE TEXAS DEPARTMENT OF HOUSING & COMMUNITY AFFAIRS (TDHCA) FOR HOME INVESTMENTS PARTNERSHIP PROGRAM FUNDING UNDER THE *HOME BUYERS ASSISTANCE GRANT (HBA)*; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS,** the City Council of the City of McKinney, Texas, has, by policy, deemed it to be in the best interest of the City of McKinney and its residents to provide affordable homeownership opportunities to low-to-moderate-income homebuyers; and

**WHEREAS,** the City desires to assist six (6) low-to-moderate-income first time homebuyers in purchasing a new home; and

**WHEREAS,** the HOME Investments Partnerships Program *Homebuyers Assistance* grant will be provided to low-to-moderate-income homebuyers in the form of a zero interest, 5-year deferred loan; and

**WHEREAS,** the City will provide a cash match of local funds from a non-federal source. The City will provide money from the fund balance of the Community Housing Fund representing the City's match of \$3,000.00; and

**WHEREAS,** the City understands that the funds available under the grant are reimbursable to the City, funds in the amount of \$20,000.00 will be committed to providing down payment assistance pending reimbursement under the grant.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

Section 1. The Interim City Manager Tom Muehlenbeck, or Designee (Rob Daake, Jose Madrigal or Barry Shelton), are hereby authorized to make application to the Texas Department of Housing & Community Affairs for grant funds under its HOME Investment Partnership Program in the amount of \$60,000.00 to assist six (6) low-to-moderate-income first time homebuyers in purchasing a new home.

Section 2. The Interim City Manager Tom Muehlenbeck, or Designee (Rob Daake, Jose Madrigal or Barry Shelton), are hereby authorized to represent and to execute the Contract and approve all documentation pursuant thereto on behalf of the City of McKinney, Texas.

Section 3. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
