

CITY COUNCIL REGULAR MEETING

JULY 20, 2021

The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, July 20, 2021 at 6:00 p.m.
