WHEREAS, HIMALAYAN VENTURES, LP. IBG ADRIATICA HOLDINGS, INC. & HIMALAYAN ST. PAUL'S SQUARE HOLDINGS, LLC are the owners of a 13.3219 acre tract of land situated in the J.R. Gray Survey, Abstract No. 343 and in the Henry Johnson Survey, Abstract No. 482, Collin County, Texas; said tract being all of Lots 6 & 7, Block A, Adriatica, an addition to the City of McKinney, Texas according to the plat recorded in Volume 2013. Page 98 of the Plat Records of Collin County, Texas: said 13.3219 acre tract being more particularly described as follows:

BEGINNING, at a 5/8—inch iron rod with "Pogue Eng & Dev" cap for corner in the easterly right—of—way line of Stonebridge Drive (a 140-foot wide right-of-way); said point also being a southwest corner of said Lot 7, Block A and the northwest corner of Lot 1R1, Block A, Adriatica Addition, an addition to the City of McKinney, Texas according to the plat recorded in Volume 2009, Page 72 of the said Plat Records: said point also being North 17 degrees, 04 minutes, 37 seconds West, a distance of 29.61 feet from a point at the north end of a right-of-way corner clip at the intersection of the said easterly line of Stonebridge Drive and the northerly right-of-way line of Mediterranean Drive (a variable width right-of-way):

THENCE, along the said easterly line of Stonebridge Drive, the following two (2) calls:

North 17 degrees, 04 minutes, 37 seconds West, a distance of 438.92 feet to a 1/2-inch iron rod found at the beginning of a tangent curve to the right;

In a northerly direction, along said curve to the right, having a central angle of 11 degrees, 57 minutes, 02 seconds, a radius of 990.00 feet, a chord bearing and distance of North 11 degrees, 06 minutes. 08 seconds West, 206.12 feet, an arc distance of 206.49 feet to a "+" cut in concrete found for corner at the end of said curve; said point also being the northwest corner of said Lot 7. Block A and the southwest corner of Lot 5, Block A. Adriatica, an addition to the City of McKinney, Texas according to the plat recorded in Cabinet Q. Page 607 of the said Plat Records;

THENCE, departing the said east line of Stonebridge Drive and along the northerly line of said Lot 7, Block A, the southerly line of said Lot 5, Block A, the southerly line of Lot 4R, Block A, Adriatica, an addition to the City of McKinney, Texas according to the plat recorded in Volume 2006, Page 543 of the said Plat Records, the southerly line of Lot 3, Block A, Adriatica, an addition to the City of McKinney, Texas according to the plat recorded in Cabinet Q, Page 597 of the said Plat Records and the southerly line of Lot 2R, Block A, Adriatica, an addition to the City of McKinney, Texas according to the plat recorded in Volume 2006, Page 240 of the said Plat Records, the following nine (9) calls:

Due East, a distance of 46.25 feet to a "+" cut in concrete found at the beginning of a tangent curve to the left:

In an easterly direction, along said curve to the left, having a central angle of 20 degrees, 26 minutes, 52 seconds, a radius of 300.00 feet, a chord bearing and distance of North 79 degrees, 46 minutes. 34 seconds East, 106.50 feet, an arc distance of 107.06 feet to a "+" cut in concrete found at the end of said curve; said point being the beginning of a reverse curve to the right;

In an easterly direction, along said curve to the right, having a central angle of 20 degrees, 26 minutes, 52 seconds, a radius of 300.00 feet, a chord bearing and distance of North 79 degrees, 46 minutes, 34 seconds East, 106.50 feet, an arc distance of 107.06 feet to a "+" cut in concrete found at the end of said curve:

Due East, at a distance of 123.37 feet passing a "+" cut in concrete found at the southeast corner of said Lot 5, Block A and the southwest corner of said Lot 4R, Block A, continuing in all a total distance of 280.29 feet to a "+" cut in concrete found at the beginning of a tangent curve to the left;

In a northeasterly direction, along said curve to the left, having a central angle of 26 degrees, 39 minutes, 18 seconds, a radius of 300.00 feet, a chord bearing and distance of North 76 degrees, 40 minutes, 21 seconds East, 138.31 feet, at an arc distance of 53.49 feet passing a "+" cut in concrete found at the southeast corner of said Lot 4R. Block A and the southwest corner of said Lot 3. Block A, continuing in all a total arc distance of 139.57 feet to a "+" cut in concrete found at the end of

North 63 degrees, 20 minutes, 42 seconds East, a distance of 36.78 feet to a "+" cut in concrete found at the beginning of a tangent curve to the right:

In a northeasterly direction, along said curve to the right, having a central angle of 21 degrees, 29 minutes, 44 seconds, a radius of 300.00 feet, a chord bearing and distance of North 74 degrees, 05 minutes, 34 seconds East, 111.89 feet, at an arc distance of 99.76 feet passing the southeast corner of said Lot 3, Block A and the southwest corner of said Lot 2R, Block A, continuing in all a total arc distance of 112.55 feet to a "+" cut in concrete found at the end of said curve:

North 84 degrees, 50 minutes, 26 seconds East, a distance of 5.15 feet to a "+" cut in concrete found at the beginning of a tangent curve to the right;

In an easterly direction, along said curve to the right, having a central angle of 20 degrees, 41 minutes, 54 seconds, a radius of 250.00 feet, a chord bearing and distance of South 84 degrees, 48 minutes. 38 seconds East. 89.82 feet, an arc distance of 90.31 feet to a "+" cut in concrete found at the end of said curve in the westerly right-of-way line of Adriatic Parkway (a 64-foot wide right—of—way); said point being the most northerly northeast corner of said Lot 7, Block A and the southeast corner of said Lot 2R, Block A; said point also being the beginning of a non—tangent curve

THENCE, departing the said northerly line of Lot 7, Block A and said southerly line of Lot 2R, Block A and along the said westerly line of Adriatic Parkway and the southerly right—of—way line of said Adriatic Parkway the following two (2) calls:

In a southeasterly direction, along said curve to the left, having a central angle of 90 degrees, 40 minutes, 58 seconds, a radius of 332.00 feet, a chord bearing and distance of South 23 degrees, 04 minutes, 08 seconds East, 472.31 feet, at an arc distance of 376.86 feet passing a 1/2-inch iron rod found at a southeast corner of said Lot 7, Block A and a northeast corner of said Lot 6. Block A. continuing in all a total arc distance of 525.46 feet to a 1/2-inch iron rod with "Poque Ena & Dev" cap set at the end of said curve:

South 68 degrees, 24 minutes, 37 seconds East, a distance of 51.58 feet to a 1/2-inch iron rod with "Pogue Eng & Dev" cap set for corner; said point also being the north end of a right-of-way corner clip at the intersection of the said southerly line of Adriatic Parkway and the said northerly line of

THENCE, departing the said southerly line of Adriatic Parkway and along the second referenced right-of-way corner clip, the following two (2) calls:

South 34 degrees, 53 minutes, 40 seconds East, a distance of 32.86 feet to a 1/2-inch iron rod with "Poque Eng & Dev" cap set at an angle point;

South 04 degrees, 39 minutes, 11 seconds West, a distance of 32.77 feet to a 5/8-inch iron rod with unreadable cap found for corner; said point being the beginning of a non-tangent curve to the right; said point also being the south end of second referenced right-of-way corner clip:

THENCE, along the said northerly line of Mediterranean Drive, the following four (4) calls:

In a southwesterly direction, along said curve to the right, having a central angle of 46 degrees, 24 minutes, 42 seconds, a radius of 311.41 feet, a chord bearing and distance of South 59 degrees, 57 minutes, 59 seconds West, 245.41 feet, an arc distance of 252.25 feet to a 5/8-inch iron rod with "Poque Eng & Dev" cap found at the end of said curve:

South 83 degrees, 10 minutes, 20 seconds West, at a distance of 432.04 feet passing a 1/2-inch iron rod found at a southwest corner of said Lot 6, Block A and a southeast corner of said Lot 7, Block A, continuing in all a total distance of 436.77 feet to a 5/8-inch iron rod with "Poque Eng & Dev" cap found at the beginning of a tangent curve to the left:

In a westerly direction, along said curve to the left, having a central angle of 10 degrees, 06 minutes, 38 seconds, a radius of 532.00 feet, a chord bearing and distance of South 78 degrees, 07 minutes, 01 seconds West, 93.76 feet, an arc distance of 93.88 feet to a 5/8-inch iron rod with "Poque Eng & Dev" cap found at the end of said curve:

South 73 degrees, 03 minutes, 42 seconds West, a distance of 161.33 feet to a 1/2-inch iron rod found for corner; said point also being a southwest corner of said Lot 7 and the southeast corner of said Lot

THENCE, departing the said northerly line of Mediterranean Drive and along the common line between said Lot 7, Block A and said Lot 1R1, Block A, the following three (3) calls:

North 16 degrees, 56 minutes, 18 seconds West, a distance of 23.77 feet to a 1/2-inch iron rod found for corner;

North 62 degrees, 00 minutes, 28 seconds West, a distance of 36.78 feet to a 5/8-inch iron rod with "Pogue Eng & Dev" cap found for corner;

South 72 degrees, 55 minutes, 23 seconds West, a distance of 57.30 feet to the POINT OF BEGINNING; CONTAINING, 580,301 square feet or 13.3219 acres of land, more or less.
