

ORDINANCE NO. 2021-06-___

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING A BUDGET AMENDMENT PERTAINING TO THE FISCAL YEAR 2020-2021 ANNUAL BUDGET; AND AUTHORIZING THE MCKINNEY ARTS COMMISSION THROUGH THE CITY MANAGER, OR HIS DESIGNEE, TO APPLY FOR, ACCEPT, IF AWARDED, ANY GRANT FUNDING FOR THE MCKINNEY SILOS ART MURAL PROJECT (GR2109); AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Council of the City of McKinney, Texas, desires to designate the City Manager or his designee, as the City's Authorized Official with the authority to apply for, accept, reject, alter or terminate a grant agreement on behalf of the McKinney Arts Commission for the McKinney Silos Art Mural Project; and

WHEREAS, as required by the City Charter, the City Manager has prepared an amendment to certain appropriations and expenditures / expenses in the 2020-2021 Budget and submitted same to the City Council for its approval and a true and correct copy is attached.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

- Section 1. The City Council of the City of McKinney, Texas, hereby approves this Ordinance and the authorization of the McKinney Arts Commission through the City Manager, or designee, to apply for and accept, if awarded, any grant funding for the McKinney Silos Art Mural Project (GR2109).
- Section 2. Pursuant to the City Charter requirements of the City of McKinney, Texas, a Budget Amendment pertaining to the Fiscal Year 2020–2021 Annual Budget is hereby authorized and approved.
- Section 3. The budget shall be amended by appropriating \$380,000 from the Hotel/Motel Fund balance and transferring same to the Public Art Fund to fund only the gap between grants and donations secured and the actual project costs for the McKinney Silos Art Mural Project (GR2109).
- Section 4. The budget shall be amended by appropriating \$380,000 to the Public Art Fund for the McKinney Silos Art Mural Project (GR2109).
- Section 5. This Ordinance shall become effective from and after its adoption and is so ordained.
