A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, AUTHORIZING THE CITY MANAGER TO APPLY FOR AND ACCEPT, IF AWARDED, FY 2014 BROWNFIELDS ASSESSMENT GRANT FUNDING FROM THE U.S. ENVIRONMENTAL PROTECTION AGENCY

- WHEREAS, the Environmental Protection Agency (EPA) Brownfields Program empowers states, cities and other stakeholders in economic development and environmental management to work together to assess, safely clean up, and sustainably reuse brownfields; and
- WHEREAS, the Town Center of the City of McKinney is generally bounded by U.S. Highway 75, U.S. Highway 380, Industrial Boulevard/Eldorado Parkway, and Airport Drive and contains neighborhoods and commercial areas that are well established, diverse, and, in some cases, historic; and
- **WHEREAS**, the Town Center of the City of McKinney may contain potential brownfield sites due to past commercial, industrial, and agricultural land use practices; and
- WHEREAS, assessment and eventual cleanup of these potential brownfield sites will enable the City of McKinney to create specific redevelopment and revitalization strategies to achieve the conceptual vision established in the Town Center Study Initiative; and
- WHEREAS, the City of McKinney was awarded Brownfields Assessment Grant Program funding from the Environmental Protection Agency through the FY 2010 Program Cycle; and
- **WHEREAS,** through the FY 2010 Brownfields Assessment Program Cycle, the City of McKinney has established and operated the McKinney Brownfields Program; and
- WHEREAS, the FY 2010 Program Cycle will expire in September 2014; and
- WHEREAS, the City of McKinney desires to continue the McKinney Brownfields Program by requesting new Program funding from the Environmental Protection Agency through the FY 2014 Program Cycle.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

Section 1. The City Council of the City of McKinney, Texas hereby authorizes the City Manager to submit an Environmental Protection Agency Brownfields Assessment Grant application and acceptance of grant, if awarded.
