15-1096 Director's Report

15-1101 Discuss Upcoming Events - Home for the Holidays

Ms. Rosenthal updated the board on the progress of the downtown Christmas tree delivery, lighting and decoration. Many hours of planning and organization have gone into having the 30 foot live tree delivered and decorated. The board discussed. The budget for Home for the Holidays was presented and discussed, the request was made to separate expenses that are for the entire season and not just the festival so that we get a better picture of the actual event expenses. Ms. Rosenthal discussed some new elements of Home for the Holidays, there will be a beer garden with Tupps and Franconia beer and TV's to watch football, a model train display and a laser show each evening.

15-1102 Discuss Retail Initiatives and Marketing Concepts

Mr. Anderson spoke to the board concerning marketing ideas for the downtown area; he suggested that downtown should explore more branding as a destination and highlighting the values offered among the merchants. He also suggested creating a new website, separate from the City of McKinney website that could highlight different retailers each week. Mr. Anderson suggested dividing downtown into 9 areas and assigning the board members as liaisons to assist with information flow and merchant feedback. Mr. Anderson would like to see a push to promote second Saturdays and recommends using social media to reach more customers and also a monthly newsletter sent to downtown so they are informed and a 3 month calendar with marketing and events. The board discussed. Ms. Rosenthal and Ms. Elwell thanked Mr. Anderson for bringing his ideas to the board.
