A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AMENDING RESOLUTION #2019-09-\_\_\_\_\_, AUTHORIZING THE CITY MANAGER TO PROVIDE ADDITIONAL, IN-KIND MATCH OF \$5,082, FOR THE DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT GRANT, THROUGH THE METRO DALLAS HOMELESS ALLIANCE, FOR CONTINUUM OF CARE RAPID REHOUSING FUNDING FOR HOUSING AND A CASE MANAGER POSITION AT THE SAMARITAN INN; AND APPROVING A MEMORANDUM OF UNDERSTANDING WITH THE SAMARITAN INN FOR THEIR \$20,000 IN-KIND CONTRIBUTION TO THE MATCH

**WHEREAS**, the City Council of the City of McKinney, Texas, believes in the dignity of all individuals; and

**WHEREAS**, the City Council of the City of McKinney, Texas recognizes the need to partner with the Samaritan Inn to apply for available grant funding to provide short-term housing assistance for individuals residing in McKinney.

**WHEREAS**, the City Council of the City of McKinney, Texas affirms its commitment to provide financial resources to this program through a minimum in-kind donation of \$56,745 and by executing a Memorandum of Understanding with the Samaritan Inn for an in-kind contribution of \$20,000

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

Section 1. The City Council of the City of McKinney, Texas hereby authorizes the City Manager to apply for, and accept if awarded, Rapid Rehousing Grant Funding through the Department of Housing and Urban Development (HUD).

Section 2. The City Council of the City of McKinney, Texas authorizes the City Manager to provide a minimum in-kind donation of City resources valued at \$56,745 and to execute a Memorandum of Understanding with the Samaritan Inn for an in-kind contribution of \$20,000.

Section 3. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
