**12-1019** Minutes of the McKinney Community Development Corporation Board Meeting of October 16, 2012.

Board members unanimously approved the motion made by board member Michael Puhl, and seconded by board member Daniel Hall to approve the minutes from the October 16, 2012 meeting.

Minutes of the Joint City Council, McKinney Community Development Corporation, and McKinney Economic Development Corporation Meeting of October 22, 2012.

Daniel Hall made a motion, seconded by Michael Puhl, to approve the Joint meeting minutes of October 22, 2012. The motion passed unanimously.

- October 2012 Financial Report. Rodney Rhoades, CFO for the City of McKinney provided the financial report. His department is working to put together a fund summary of current projects and prior year financial commitments. The sales tax receipts for the month of October were \$716,718. This is up 5.9% from October, 2011. The year-to-date sales tax receipts are up 19.8% from 2011.

- The annual State of the Community luncheon was held November 8<sup>th</sup>. Close to 500 people attended the event.
- The McKinney Buy Local! Campaign will be featured in a six-part promotion in the Courier Gazette. The promotion will begin just prior to Dickens of a Christmas in November.
- A holiday promotion the 12 Days of Christmas will be rolled out between Thanksgiving and Christmas and feature 12 local merchants.
- The Chamber legislative agenda will be previewed at the Chamber breakfast at Eldorado Country Club on December 11<sup>th</sup>.

### Collin County Regional Airport

- The runway dedication was held November 9<sup>th</sup>. Airport staff continues to receive positive feedback on the runway throughout the industry.
- The terminal complex will be the next improvement in the airport master plan the Collin County Airport Development Board will begin work on.

#### McKinney Convention & Visitor's Bureau

- The MCVB assisted five groups planning day trips to McKinney this past month.
- The hotel room count for the past month totaled 305, for a total value of \$41,361.
- The MCVB staff participated in the Texas Booth at the Albuquerque Balloon Festival October 5-13. There were 2,500 leads generated from the event.
- The MCVB will move to their new office located at 200 W. Virginia by late January.

#### Parks, Recreation & Open Spaces

- The dog park at Bonnie Wenk Park will be the first portion of the park to be completed.
- Gabe Nesbitt Park skate park has begun construction.

Michael Puhl made a motion to approve a settlement agreement and release subject to the city providing the missing dates thereon and contingent on funding \$750,000 (\$375,000 City, \$375,000 MCDC) into an escrow account. The escrow agent shall be a non-affiliated third party. The motion was seconded by Kevin Griffin and passed unanimously.

## **12-1024** Executive Director's Report

- Board committee assignments were discussed. A liaison has been added to the CCADB. Jason Burress will serve as the airport board liaison.
- The new MCDC website has added a board member portal, log-in information was provided to all board members.
- The Crape Myrtle Trails Run, an event supported with MCDC grant funds, will be held November 17<sup>th</sup>.
- The Especially Needed Fall Carnival was very well attended.
- A Make A Difference Day video was shown to the board.
- Discussions on the Public Art Master Plan continue. The arts commission is working to prioritize locations and types of art for placement within the City of McKinney.
- The next cycle for Promotional and Community Event grants is open. Applications will be accepted through December 20<sup>th</sup>. The applications will be heard by the board during the January board meeting, and voted on in February.

Michael Puhl made a motion to adjourn the meeting. The motion was seconded by Jason Burress. The motion passed unanimously. The meeting was adjourned at 9:11 a.m.
