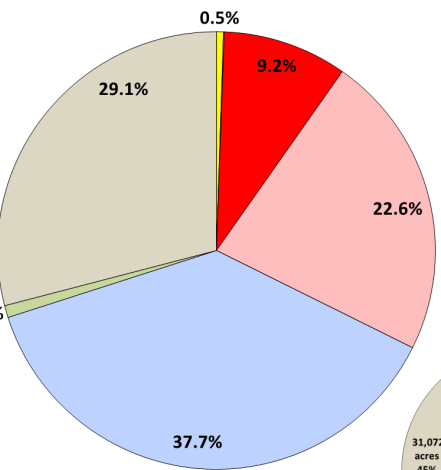

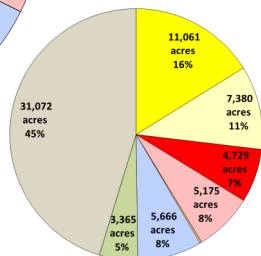

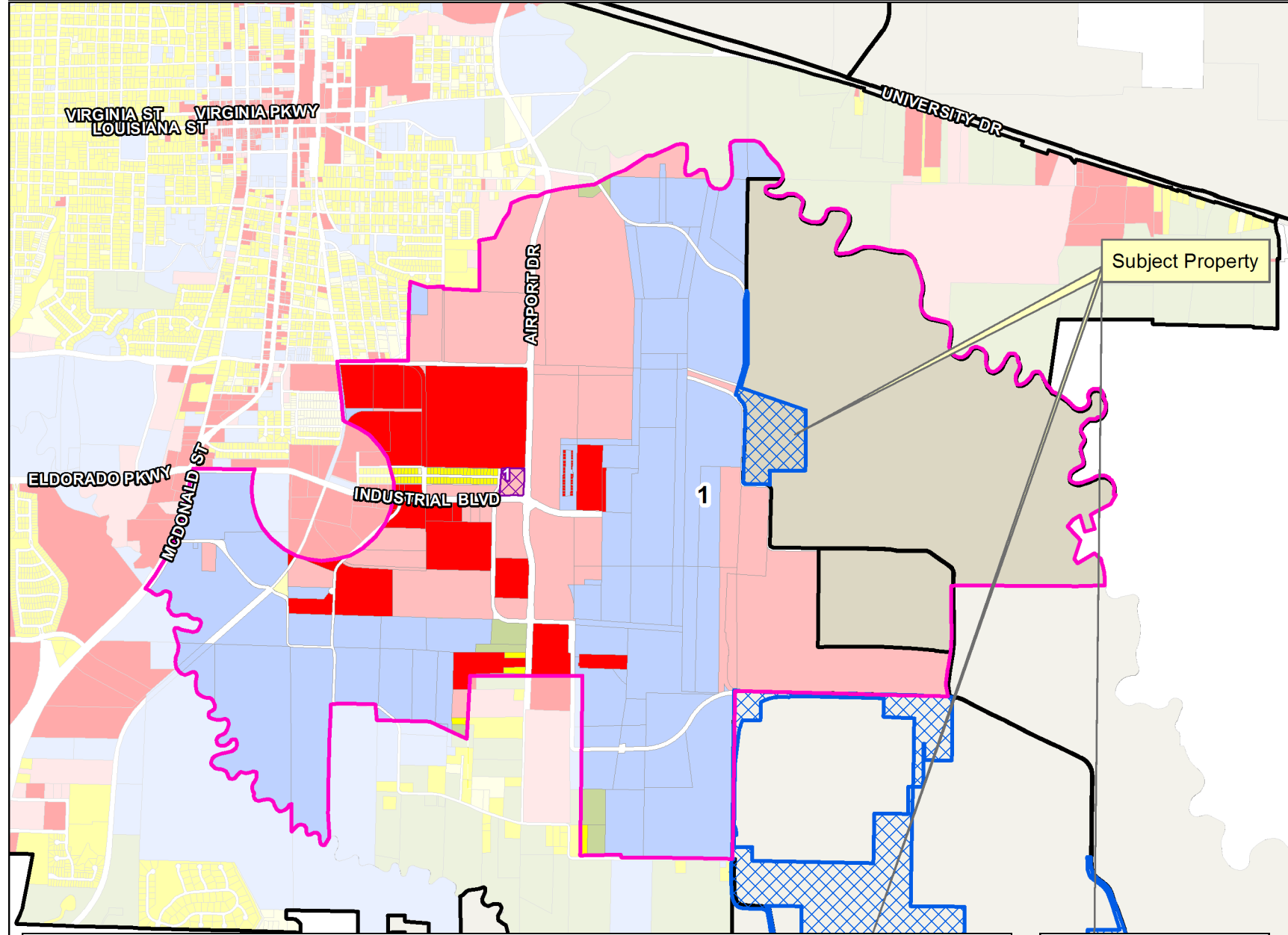

#### Citywide and ETJ

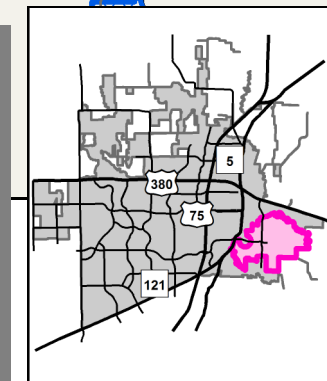

Approved Projects Impacting Land Use or Tax Base (2015, 2016)<sup>4</sup>

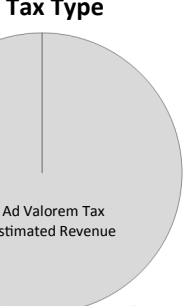
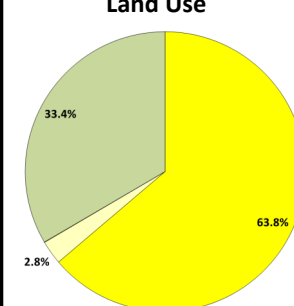
