

ORDINANCE NO. 2016-06-___

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, ESTABLISHING A SPEED LIMIT ON C.R. 164 (FUTURE BLOOMDALE ROAD), C.R. 331 (WOODLAWN ROAD), AND C.R. 722 (ENLOE ROAD) IN MCKINNEY; AMENDING THE CODE OF ORDINANCES, CITY OF MCKINNEY, TEXAS; PROVIDING FOR PUBLICATION OF THE CAPTION OF THE ORDINANCE, EFFECTIVE DATE HEREOF AND A PENALTY CLAUSE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

Section 1. The City Council of the City of McKinney, Texas, hereby amends the Code of Ordinances by adding a section in Chapter 62, Article II, to be numbered 62 – 111.3, which will read as follows:

Sec 62-111.3. C.R. 164

When no special hazards exist that require a lower speed limit for compliance with this article, the speed of any vehicle not in excess of the limit of this section shall be lawful, but any speed in excess of the limits in each speed zone shall be prima facie evidence that the speed is not reasonable or prudent and that it is unlawful:

Zone 1, which extends along the annexed section on C.R. 164 from Lake Forest Drive (FM 1461) to C.R. 201, a speed limit of 45 miles per hour.

Section 2. The City Council of the City of McKinney, Texas, hereby amends the Code of Ordinances by adding a section in Chapter 62, Article II, to be numbered 62 – 111.4, which will read as follows:

Sec 62-111.4. C.R. 331

When no special hazards exist that require a lower speed limit for compliance with this article, the speed of any vehicle not in excess of the limit of this section shall be lawful, but any speed in excess of the limits in each speed zone shall be prima facie evidence that the speed is not reasonable or prudent and that it is unlawful:

Zone 1, which extends along the annexed section on C.R. 331 from University Drive (US 380) to FM 2933, a speed limit of 45 miles per hour.

Section 3. The City Council of the City of McKinney, Texas, hereby amends the Code of Ordinances by adding a section in Chapter 62, Article II, to be numbered 62 – 111.5, which will read as follows:

Sec 62-111.5. C.R. 722

When no special hazards exist that require a lower speed limit for compliance with this article, the speed of any vehicle not in excess of the limit of this section shall be lawful, but any speed in excess of the limits in each speed zone shall be prima facie evidence that the speed is not reasonable or prudent and that it is unlawful:

Zone 1, which extends along the annexed section on C.R. 722 from FM 546 to Airport Drive, a speed limit of 40 miles per hour.

Section 4. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, after all the necessary signs and markings have been installed, and it is accordingly so ordained.

Section 5. Any person who violates any provisions of this Ordinance shall be guilty of a misdemeanor and, upon conviction, shall be subject to a fine not to exceed two thousand dollars (\$2000).
