presentation on the progress of the 2019 Impact Fee Update. Vice-

Chairman Mantzey asked about the land use assumptions and how it

was stressed tested. Mr. Bloxham explained that there were a lot of

technical calculations used for the various land uses in the study. He

stated that the impact fees were updated every five years and the Semi-

Annual Impact Fee Reports were given to review the data twice a year.

Commission Member Doak asked how changing zonings on properties

impacted it. Mr. Bloxham stated that a change in zoning could make a

small impact. Commission Member Doak asked why Staff was redlining

#4 shown in the Staff Report. Mr. Bloxham stated that it would take the

City up to the maximum impact fee for every single item we have, which

would put us out of touch with what our sister cities collect in impact fees.

He stated that there could be some unique situations where we would

need to make some changes. Mr. Bloxham stated that the City tries to

be developer friendly. Chairman Cox asked for clarification on what Staff

will be recommending for the wastewater impact fee amount. Mr.

Bloxham stated that Staff will go back to look at the numbers compared

to what the sister cities charge. Mr. Bloxham stated that the next

presentation should be held in October 2020. No action was taken on

this item.
