Ms. Best reminded members funding allocations at this time are only careful estimates. Due to the federal sequester, the City still has not received its funding allocation for FY 2014 at the time of the CGAC's deliberation. requirements, funding of public services must not exceed 15% of the total grant and grant administration funding cannot exceed 20% of the total grant due to statutory law. To ensure the City continues to meet federal reporting and program requirements of the U.S. Department of Housing and Urban Development (HUD), Ms. Best stated flexibility must be allowed distribute any reductions or increases of CDBG funding to the City programs and activities, as it is likely HUD will release allocation of all national funding after the deliberation. It will not impact recommendations to any proposed agency and the City will stay under the required caps. The public will receive all information and any adjustments through the City's CDBG Annual Action Plan, which is always placed under review of public comment for 30 days, prior to the final public hearing at the City Council Regular Meeting on July 16. The U.S. Department of Housing and Urban Development must receive the City's Plan no later than August 15 for consideration. The City will not receive funding until October 1 for FY 2014. Ms. Best stated flexibility may increase or reduce the following activities:
