

NOTE: THE CONTRACTOR SHALL VERIFY WATER RESTRICTIONS WITHIN THE CITY OF MCKINNEY AT TIME OF PLANTING. SHOULD WATER RESTRICTIONS NOT ALLOW HYDRO-MULTH, HYDRO-SEEDING, OR SPRIGGING (STAGE 3 AND STAGE 4 WATER RESTRICTIONS), AN APPROVED ALTERNATIVE FOR GRASSING SHALL BE INSTALLED.

#### LANDSCAPE NOTES:

- 1. CONTRACTOR SHALL VERIFY EXISTING AND PROPOSED SITE ELEMENTS AND NOTIFY OWNER'S AUTHORIZED REPRESENTATIVE OF ANY DISCREPANCIES.
- 2. CONTRACTOR SHALL LOCATE EXISTING UNDERGROUND UTILITIES AND NOTIFY OWNER'S AUTHORIZED REPRESENTATIVE OF ANY CONFLICTS. CONTRACTOR SHALL EXERCISE CAUTION WHEN WORKING IN THE VICINITY OF UNDERGROUND UTILITIES.
- 3. EXISTING LANDSCAPE TO REMAIN SHALL BE PROTECTED IN-PLACE. CONTRACTOR SHALL REPAIR AND REPLACE ANY DAMAGED OR DISTURBED LANDSCAPE AND IRRIGATION TO REMAIN.
- 4. CONTRACTOR SHALL PROVIDE A MINIMUM 2% SLOPE AWAY FROM STRUCTURES.
- 5. MAINTAIN PLANTING BEDS  $\frac{1}{2}$ " BELOW THE TOP OF SIDEWALKS AND CURBS. MAINTAIN PLANTER BEDS 3" BELOW TOP OF PLANTERS.
- 6. CONTRACTOR SHALL PROVIDE BID PROPOSAL LISTING UNIT PRICES FOR MATERIALS PROVIDED.
- 7. CONTRACTOR SHALL BE RESPONSIBLE FOR OBTAINING REQUIRED LANDSCAPE AND IRRIGATION PERMITS.
- 8. THE OWNER, TENANT AND THEIR AGENT SHALL BE JOINTLY AND SEVERALLY RESPONSIBLE FOR THE MAINTENANCE OF LANDSCAPE.
- 9. LANDSCAPE SHALL BE MAINTAINED IN A NEAT AND ORDERLY MANNER. THIS SHALL INCLUDE MOWING, EDGING, PRUNING, FERTILIZING, WATERING, WEEDING AND OTHER SUCH ACTIVITIES COMMON TO LANDSCAPE MAINTENANCE.
- 10. LANDSCAPE AREAS SHALL BE KEPT FREE OF TRASH, LITTER, WEEDS AND OTHER SUCH MATERIAL OR PLANTS NOT PART OF THIS PLAN.
- 11. PLANT MATERIAL SHALL BE MAINTAINED IN A HEALTHY AND GROWING CONDITION AS IS APPROPRIATE FOR THE SEASON OF THE YEAR.
- 12. PLANT MATERIAL WHICH DIES SHALL BE REPLACED WITH PLANT MATERIAL OF EQUAL OR BETTER VALUE
- NOTE: TREES SHALL HAVE STRAIGHT TRUNKS AND BE MATCHING WITHIN VARIETIES. PLANT LIST IS AN AID TO BIDDERS ONLY. CONTRACTOR SHALL VERIFY QUANTITIES ON PLAN. HEIGHT AND SPREADS ARE MINIMUMS. 


