**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING A BUDGET AMENDMENT PERTAINING TO THE FISCAL YEAR 2016-2017 BUDGET AND THE 2017 - 2021 CAPITAL IMPROVEMENTS PROGRAM TO APPROPRIATE FUNDS FROM THE COLLIN COUNTY PARKS AND OPEN SPACE PROJECT FUNDING ASSISTANCE PROGRAM TO BONNIE WENK PARK PHASE II; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, as required by the City Charter, the City Manager has prepared an amendment to certain appropriations and expenditures/expenses in the 2016-2017 Budget and the 2017 - 2021 Capital Improvements Program and submitted same to the City Council for its approval and a true and correct copy is attached.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

- Section 1. Pursuant to the City Charter requirements of the City of McKinney, Texas, in the Fiscal Year 2016-2017 Budget Amendment as attached is hereby authorized and approved.
- Section 2. The budget shall be amended by transferring \$461,256 grant from the Collin County Parks and Open Space Project Funding Assistance Program and appropriating the amount in the Parks Construction Fund to PK3222, the Bonnie Wenk Park Phase II project.
- Section 3. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, and it is accordingly so ordained.
