MARCH 1, 2016

The City Council of the City of McKinney, Texas met in regular session in the Council Chambers of the Municipal Building on March 1, 2016 at 6:00 p.m

15-343Z5 Mayor Loughmiller called for a Public Hearing to Consider/Discuss/Act on a Request to Rezone the Subject Property from "PD" - Planned Development District and "CC" - Corridor Commercial Overlay District to "C2" - Local Commercial District and "CC" - Corridor Commercial Overlay District, Located on the Northeast Corner of U.S. Highway 380 (University Drive) and Hardin Boulevard, and Accompanying Ordinance. Director of Planning Brian Lockley stated the applicant has requested that the public hearing be continued and the item tabled to the March 15, 2016 City Council meeting. Mayor Loughmiller called for public comments and there were none. Council unanimously approved the motion by Mayor Pro Tem Ussery, seconded by Council member Branch, to continue the public hearing and table this item to the March 15, 2016 meeting.

Mayor Loughmiller called for a Public Hearing to Consider/Discuss/Act on a Request to Rezone the Subject Property from "PD" - Planned Development District and "REC" - Regional Employment Center Overlay District to "C1" - Neighborhood Commercial District, Located on the Northwest Corner of Lake Forest Drive and Collin McKinney Parkway, and Accompanying Ordinance. Director of Planning Brian Lockley stated that the applicant is requesting to rezone the property located at the corner of Lake Forest Drive and Collin McKinney Parkway in order to offer more retail and remove the setback requirement that is part of the Regional Employment Center Overlay District. That requirement calls for the rear setback to be 55', which moves the building up to the street. The applicant would like to reduce that setback to allow for a more suburbantype development. Applicant, Mr. Patrick Filson, Kirkman Engineering, 4221 Merlot Avenue, Grapevine, was available for questions and there were none. Mayor Loughmiller called for public comments and there were none. Council unanimously approved the motion by Councilwoman Rath, seconded by Council member Pogue, to close the public hearing. Council unanimously approved the motion by Mayor Pro Tem Ussery, seconded by Council member Branch, to approve an Ordinance rezoning the subject property from "PD" - Planned Development District and "REC" - Regional Employment Center Overlay District to "C1" -Neighborhood Commercial District, located on the northwest corner of Lake Forest Drive and Collin McKinney Parkway. Caption reads as follows:

a Site Plan for a Parking Lot (Buick-GMC Inventory Parking), Located on the North Side of Collin McKinney Parkway and at the Terminus of Test Drive. Director of Planning Brian Lockley stated the applicant is requesting to add a parking lot for approximately 136 parking spaces adjacent to the property to address inventory overflow. It is a requirement of the PD that it come to Council for approval. Applicant, Mr. Robert Sanders with Berkshire Hathaway Automotives was present to answer questions. Mayor Loughmiller called for public comments.

Council unanimously approved the motion by Mayor Pro Tem Ussery, seconded by Council member Pogue, to close the public hearing. Mr. Lockley stated that the applicant proposed a six foot tubular fence with masonry columns along the perimeter of the property. The landscape plan will provide a live screen as well as buffer the impact to the adjacent properties. Lighting will have to be downcast and the foot candles will have to meet the minimums at the property lines to ensure they are downcast and not spilling over into the adjacent properties. Director of Engineering Mark Hines stated plans have been submitted to dig a ditch that will handle the 100 year flood with one foot of free board which should handle the drainage issues. This development will contribute to that drainage but they will be required to either take the water into a pond to the north or make provisions on site for detention.

They will be required to mitigate the drainage so that there will be no additional damage to adjacent properties. Mr. Lockley stated there is a grade change between the properties of about 15 feet that will affect the height and effectiveness of the screening wall. The lighting ordinance does not require shielding of any kind. It requires that no more than .25 foot candles spill over into residential properties. Pole heights are regulated by the lighting ordinance and the zoning ordinance. Charles Garcia, Freeland and Kauffman, Inc., Civil Engineers, stated that this is an inventory lot that will be lit minimally for security only. For drainage, there is a storm line coming in from the south across Collin McKinney Parkway that is discharging into the ditch on site. That will be piped to the back of the property and should eliminate any concern of drainage. The screening wall will be put at the curb level if we are allowed to do that. Applicant is also willing to make the screening wall adjacent to the residents a solid masonry wall. Council unanimously approved the motion by Council member Pogue, seconded by Mayor Pro Tem Ussery, to approve a Site Plan for a parking lot (Buick-GMC Inventory Parking), located on the north side of Collin McKinney Parkway and at the Terminus of Test Drive with modifications of the location of the six foot tubular wrought iron screening wall and live screening to be moved within the area proximity back of curb and the area in the northwest corner adjacent to the single-family converted to a solid screen wall as proposed by the applicant.

Fire Chief Danny Kistner stated that the Fire Department is requesting approval to purchase the 100' aerial ladder apparatus as replacement to existing apparatus number 750 that has exceeded its service life. Office

of Emergency Management recommends replacement after 9,000 hours of service and this apparatus has 12,000 hours. Council unanimously approved the motion by Councilwoman Rath, seconded by Council member Branch, to approve a Resolution authorizing the purchase of one new Fire Apparatus equipped with a 100' aerial ladder from Hall-Mark Fire Utilizing the Houston Galveston Area Council Cooperative Contract FS12-15. Caption reads as follows:

- 16-261 Mayor Loughmiller called for Consideration/Discussion/Action on Water Service Line Replacement Program. Interim City Manager Tom Muehlenbeck stated the details of this project on how to reduce the water loss was presented to Council during the work session on February 29, 2016. Two options were presented. One is to contract that service out and one is to do the work in house. Water Wastewater Superintendent Morgan Dadgostar stated that this is a 10-year program in which over 14,000 of these connections will be replaced. The plan is to purchase the equipment during this budget year but funding for staffing will not be available until October 2016. Council unanimously approved the motion by Mayor Pro Tem Ussery, seconded by Councilwoman Rath, to approve Water Service Line Replacement Program the with staff's recommendation that the process be done internally.
- 16-262 Mayor Loughmiller called for Consideration/Discussion/Action on an Ordinance Amending the Fiscal Year 2015-2016 Annual Budget to Provide Funds for the Water Service Line Replacement Program. Interim City Manager Tom Muehlenbeck stated this item is the request for a budget transfer for fiscal year 2015-16 of \$1,759,647 to provide the funds

for purchasing the equipment in order to be ready to start the water service line replacement project on October 1, 2016. Council unanimously approved the motion by Councilwoman Rath, seconded by Council member Branch, to approve an Ordinance amending the Fiscal Year 2015-2016 Annual Budget to provide funds for the Water Service Line Replacement Program. Caption reads as follows:

Council unanimously approved the motion by Council member Rogers, seconded by Council member Pogue, to appoint Bridgette Wallis to fill the vacant position on the McKinney Housing Finance Corporation starting March 2, 2016 and ending September 30, 2017.

Mayor Loughmiller called for Consideration/Discussion/Action on Appointing Members to the Model Code Evaluation Subcommittee.

Executive Director of Development Services Michael Quint stated that staff is requesting Council appoint five members to the Model Code Evaluation Subcommittee. Council reviewed the list of recommended names and preferenced their selection. Council unanimously approved the motion by Council member Pogue, seconded by Council member Branch, to appoint the following individuals to serve on the Model Code Evaluation Subcommittee: Paul Abernathy, Jon David Cross, Levi Wild, and Kobey Seale. Council unanimously approved the motion by Council

member Branch, seconded by Councilwoman Rath, to appoint David Vartian to serve on the Model Code Evaluation Subcommittee.

Mayor Loughmiller called for Consideration/Discussion/Action on 16-265 Appointing Members to the Downtown Parking Committee. Mayor Loughmiller stated the names submitted for consideration are: District 1 – Rick Wells and Tom Meredith; District 3 - George Bush and Larry Curfman; Council member Pogue - Larry Horner and Kim Black; Councilwoman Rath – Karen Chandler and Kathryn Waite; Mayor – Rick Weaver; District 2 - Wes Hendricks; District 4 - Tracy Carruth; City Manager's as non-voting members – Barry Shelton and Patricia Jackson; and City Council representatives as non-voting members - Mayor Loughmiller and Councilwoman Rath. These meetings will be held in the Council Chamber and will be televised. Interim City Manager stated that staff will provide copies of the studies and background material to each member. The committee has a target date of mid-May for presentation to Council and will provide updates with liaison reports. Council unanimously approved the motion by Mayor Pro Tem Ussery, seconded by Council member Pogue, to appoint the following individuals to serve as voting members of the Downtown Parking Committee: Rick Wells, Tom Meredith, George Bush, Larry Curfman, Larry Horner, Kim Black, Karen Chandler, Kathryn Waite, Rick Weaver, Wes Hendricks, and Tracy Carruth.

Mayor Loughmiller called for Citizen Comments and there were none.

Mayor Loughmiller called for Council and Manager Comments.

Council member Branch thanked staff for providing good information to him relating to parks, traffic study, as well as the low income housing project.

Council member Day did not have any comments.

Council member Pogue did not have any comments.

Council member Rogers stated that on February 20th the City lost a life-long member of the community. My Father-in-Law, Mr. William Crump, was a good guy and will be missed.
