**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING A CERTAIN BUDGET AMENDMENT PERTAINING TO THE FISCAL YEAR 2021-2022 ANNUAL BUDGET, TO PROVIDE \$3,000,000 IN ADDITIONAL FUNDING FOR THE COLLIN COUNTY ALLOCATION OF ROUND 2 CARES ACT FUNDING FOR THE RENTAL AND UTILITY ASSISTANCE PROGRAM; AND PROVIDING FOR AN EFFECTIVE DATE HEREOF**

**WHEREAS**, as required by the City Charter, the City Manager has prepared an amendment to certain appropriations and expenditures / expenses in the Fiscal Year 2021-2022 Annual Budget and submitted same to the City Council for its approval and a true and correct copy is attached.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

- Section 1. Pursuant to the City Charter requirements of the City of McKinney, Texas, a Budget Amendment pertaining to the Fiscal Year 2021-2022 Annual Budget is hereby authorized and approved.
- Section 2. The budget shall be amended by appropriating an additional \$3,000,000 in the County ILA COVID Response Fund for the Collin County allocation of Round 2 Cares Act funding for the Rental and Utility Assistance Program for a total of \$8,486,423.
- Section 3. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, and it is accordingly so ordained.
