## **CITY COUNCIL SPECIAL MEETING**

## **FEBRUARY 25, 2013**

The City Council of the City of McKinney, Texas met in special session in the Council Chambers of the Municipal Building on February 25, 2013 at 5:30 p.m.

Council Present: Mayor Pro-Tem Travis Ussery, Council members: Geralyn Kever, Don Day, Ray Ricchi, and Roger Harris. Mayor Brian Loughmiller arrived at 5:36 p.m. Absent: Council member David Brooks.

Staff Present: City Manager Jason Gray; Deputy City Manager Rob Daake; City Attorney Mark Houser; City Secretary Sandy Hart; Director of Planning Michael Quint; Assistant Director of Planning Kevin Spath; Executive Director of Development Services Barry Shelton; Assistant Director of Development Services Rick Leisner; Construction Facilities Manager Patricia Jackson; Chief Financial Officer Rodney Rhoades; McKinney Economic Development Corporation President Jim Wehmeier; McKinney Community Development Corporation Executive Director Cindy Schneible; and Director of Engineering Jack Carr.

There were 8 guests present.

Mayor Pro-Tem Ussery called the meeting to order at 5:32 p.m. after determining a quorum present. Mayor Pro-Tem Ussery turned the work session over to City Manager Jason Gray. Mr. Gray called for discussion on the following item with no action taken:

- City Manager Gray called for the Development Services Update (Barry Shelton) (30 minutes). Executive Development Services Director Barry Shelton presented the department report that included Planning, Engineering, Building Inspections, and Code Compliance that includes 88 full time and 1 part-time staff. The Development Services Division provides for an enhanced quality of life, a safe community, a healthy environment, and a well-planned future through the effective and efficient management of the departments within Development Services.
- Mayor Loughmiller called for Consideration/Discussion/Action on a Resolution Approving the Selection of a Construction Manager at Risk for the Gateway Hotel and Events Center Project. City Manager Gray stated

that the City will have a Construction Manager at Risk for the Events Center project. Mr. Gray stated that five companies submitted statements of qualifications in response to the RFQ. Beck Construction was evaluated as the most qualified firm to perform the CMAR services for the project. Staff is recommending approval of Beck Construction as the CMAR for the Event Center. Council approved the motion by Council member Kever, seconded by Council member Harris, to approve a Resolution approving the selection of a Construction Manager at Risk for the Events Center Project with a vote of 4-2-0, Mayor Pro-Tem Ussery and Council member Ricchi, voting against. Mayor Loughmiller called for Mayor and Council Updates

Mr. Loughmiller stated that he also attended an economic development meeting with McKinney Economic Development Corporation Vice President Abby Liu, Judge Keith Self, and economic development representatives around Collin County to talk about joint efforts. Judge Self is working on ways for Collin County to come together to work on ways to encourage businesses to come to the area. There is a Collin County Regional Partnership that works on marketing issues. The City is also involved in Texas One and Team Texas which are also joint efforts.
