Council Goals and Priorities. The City Manager, MCDC Executive Director, and MEDC President would meet on a regular basis and communicate to their respective boards the City Council goals and objectives as they relate to economic development and quality of life and what the expectations are for those goals and policies. Manager, MEDC President and the MCDC Executive Director will be working together with any prospective projects from inception through completion. The boards will need to work on strategies regarding economic development. The Council's priorities over the last two years include creating Tax Increment Reinvestment Zones, resolve the Gateway issues, designate a corporate center through the RFQ process, and a plan to increase development at the Airport. To date, the Council has established the two reinvestment zones, will be voting on the Gateway agreements at the next Council meeting, established a corporate center at Craig Ranch, and the airport has a new runway, an airport layout plan, and a new control tower. Questions that came out of the discussion: Does the land use plan support our goals? What goes where relates to work the Council needs to do on the northwest quadrant study. What are target markets? What are the need-to-haves as far as the type of markets where we need to be aggressive with? How do we provide a single efficient path for these businesses? How do we work together as a team with these clients? Council will provide direction to both MCDC and MEDC about what the Council priorities are. It was suggested that the City Council will need to decide where Council is regarding economic development, where do we want to be, how do we want to go after these markets, and how do we want to spend these collective buckets of money.
