Reference: Proposed Simple Storage Facility East of Hardin Blvd and North of McKinney Ranch Parkway and adjacent to Eldorado Pointe Neighborhood.

I am a resident of the Eldorado Pointe neighborhood and the Vice President of the Eldorado Pointe Home Owners Association. I support the construction of the proposed storage facility. The project engineer, Joshua Baran, has provided our neighborhood with plans and drawings. I have discussed those plans and shared the drawings with interested homeowners in Eldorado Pointe and there is general agreement that we support the storage facility project.

One reason is that it will provide a buffer to the McKinney ISD football stadium to be built to the south of McKinney Ranch Parkway. Many homeowners in Eldorado Pointe were opposed to the construction of the stadium for various reasons, with noise and light pollution among those reasons.

Additionally, the proposed site plan that has been provided to us by the storage facility engineer shows that the proposed extension of Denver drive from Eldorado Pointe will only be a "stub out – hammerhead" turnaround for McKinney fire department emergency use (drawing 16-165 Sup Updated Site Plan). This will eliminate the concerns we have that an extension of Denver drive, all the way to McKinney Ranch Parkway, would result in significant traffic safety and security issues to the Eldorado Pointe neighborhood.

I also support the proposed change to eliminate the requirement that a masonry fence be built along the property line between Eldorado Pointe (south of portions of Vail drive and Aspen drive) and the storage facility. The storage facility engineer has proposed an alternate plan to provide a 25 foot "green space" with grass and trees between the property line and the storage facility. The storage facility would be responsible for the construction and maintenance of that greenspace area. The proposal also includes the addition of solid, lockable doors in the space between the individual buildings. These doors would be locked and only the McKinney fire department would have the keys to open the doors (drawing 16009 – Simply McKinney – Alley Rendering).




