

## **CITY COUNCIL WORK SESSION**

**OCTOBER 4, 2021**

The City Council of the City of McKinney, Texas met in work session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas on Monday, October 4, 2021 at 4 p.m.

Mayor Fuller called for Public Comments.

Darrell Hale, 3705 Amos Carter, McKinney, TX 75069, spoke regarding Agenda Item #21-0008A2/21-0087Z3 on the Regular Agenda.

Mayor Fuller called for discussion of the agenda items to be presented at the City Council Regular Meeting of Monday, October 4, 2021, at 6:00 p.m.

Director of Planning Jennifer Arnold and Director of Engineering Gary Graham spoke regarding Agenda Item # 21-0008A2/21-0087Z3 (Conduct a Public Hearing to Consider/Discuss/Act on a Petition to Annex (Case No. 21-0008A) and a Request to Zone (Case No. 21-0087Z) on Certain Land (the "Property") to "PD" – Planned Development District, Located on the East Side of County Road 317 and Approximately
