## **REPORTS**

October 2013 Financial Report. Executive Director Guerra stated that the finance committee did not meet. Guerra also advised board members that the Made in McKinney Store surpassed the previous monthly sales by \$300 and continues to see more foot traffic as citizens and visitors learn about the stores existence. Chair McEntire advised that the hotel receipts for September were over one million dollars, and the year-end hotel receipts was over ten million dollars in receipts, stating that the hotel receipts continue to improve year over year.

13-1243 Board and Liaison Updates: Board Chair, Chamber of Commerce City of McKinney, and MPAC/Main Street. There were no representatives present from MPAC/Main Street, the City, or Chamber of Commerce to give updates. Councilman Pogue gave an update on the current status of the new Sheraton Gateway project. Board member Vranici asked when the CVB should begin to sell and advertise the convention & hotel space to associations and corporations. Executive Director Guerra stated that she was advised by MCDC Executive Director Cindy Schneible at the marketing round table that they would advise the CVB when advertising should begin based on timeline and feedback from the management company. Councilman Pogue also advised board members of the new Hampton Inn & Suites that is under construction north east of University/380 and Hwy 75.

13-1244 Executive Director Report. Executive Director Guerra advised board members that McKinney has a new B & B, The Red Gate Inn Bed & Breakfast, which will open in February 2014. Guerra also advised that a few of the McKinney B & B's were not paying Hotel Taxes to the city and she had contacted city Finance Director Rhoades to look into the matter.

Guerra advised board members that staff had assisted in securing 349

hotel rooms during the month of October and had processed 2900 leads.

In addition, Guerra highlighted that the MCVB weekly e-newsletter

continues to have a 30% open rate which is above the industry standard

and that the visitor's center welcomed 236+ visitors to the center. For the
