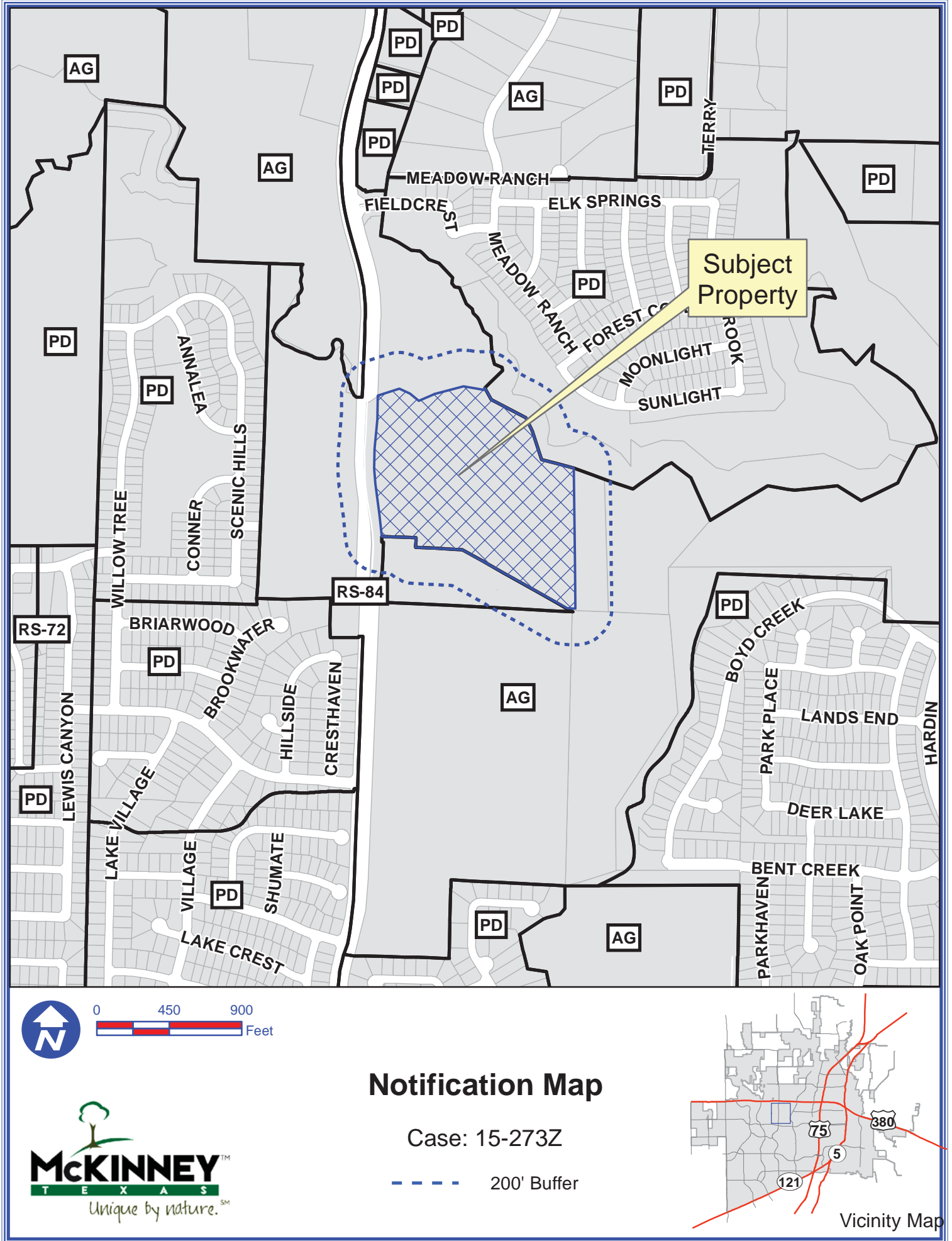

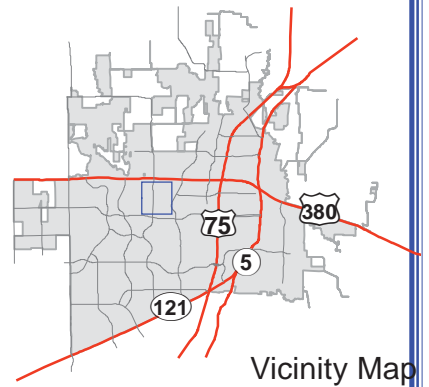

BEING A 33.654 ACRE TRACT OF LAND SITUATED IN THE WILLIAM H. HUNT SURVEY, ABSTRACT NO. 450, IN THE CITY OF MCKINNEY, COLLIN COUNTY, TEXAS AND BEING A PORTION OF A 59.12 ACRE TRACT OF LAND ACCORDING TO THE DEED RECORDED IN VOLUME 3942, PAGE 107 OF THE DEED RECORDS OF COLLIN COUNTY, TEXAS (DRCCT) AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A 5/8 INCH IRON ROD SET FOR CORNER LOCATED AT THE POINT OF INTERSECTION OF THE SOUTHERLY LINE OF SAID 59.12 ACRE TRACT OF LAND WITH THE EASTERLY RIGHT-OF-WAY LINE OF LAKE FOREST DRIVE (A 120 FEET WIDE RIGHT-OF-WAY);

THENCE ALONG THE EASTERLY RIGHT-OF-WAY LINE OF SAID LAKE FOREST DRIVE AS FOLLOWS:

NORTH 01°33' 00" EAST A DISTANCE OF 310.14 FEET TO A 5/8 INCH IRON ROD SET FOR THE BEGINNING OF A CURVE TO THE LEFT HAVING A RADIUS OF 1,260.00 FEET AND A CHORD BEARING OF NORTH 02°49' 29" WEST;

ALONG SAID CURVE TO THE LEFT THROUGH A CENTRAL ANGLE OF 09°24' 05" FOR AN ARC LENGTH OF 206.75 FEET TO A 5/8 INCH IRON ROD SET FOR THE POINT OF TANGENCY;

NORTH 07°31' 31" WEST A DISTANCE OF 225.82 FEET TO A 5/8 INCH IRON ROD SET FOR THE BEGINNING OF A CURVE TO THE RIGHT HAVING A RADIUS OF 1,140.00 FEET AND A CHORD BEARING OF NORTH 02°59' 15" WEST;

ALONG SAID CURVE TO THE RIGHT THROUGH A CENTRAL ANGLE OF 09°04' 31" FOR AN ARC LENGTH OF 180.57 FEET TO A 5/8 INCH IRON ROD SET FOR THE POINT OF TANGENCY;

NORTH 01°33' 00" EAST A DISTANCE OF 356.74 FEET TO A POINT FOR CORNER LOCATED IN THE NORTHERLY LINE OF SAID 59.12 ACRE TRACT OF LAND AND BEING LOCATED IN OR NEAR THE CENTER OF WILSON CREEK;

THENCE FOLLOWING THE NORTHERLY LINE OF SAID 59.12 ACRE TRACT OF LAND ALONG OR NEAR THE CENTER OF WILSON CREEK AS FOLLOWS:

NORTH 69°36' 10" EAST A DISTANCE OF 143.72 FEET TO A POINT FOR CORNER;

SOUTH 67°03' 50" EAST A DISTANCE OF 72.40 FEET TO A POINT FOR CORNER;

SOUTH 51°06' 50" EAST A DISTANCE OF 71.80 FEET TO A POINT FOR CORNER;

NORTH 74°13' 10" EAST A DISTANCE OF 186.60 FEET TO A POINT FOR CORNER;

NORTH 08°54' 05" EAST A DISTANCE OF 13.23 FEET TO A POINT FOR CORNER;

SOUTH 30°44' 20" EAST A DISTANCE OF 83.53 FEET TO A POINT FOR CORNER;

SOUTH 62°49' 37" EAST A DISTANCE OF 243.34 FEET TO A POINT FOR CORNER;

THENCE ALONG THE SOUTHERLY LINE OF SAID 59.12 ACRE TRACT OF LAND NORTH 88°25' 40" WEST A DISTANCE OF 1,199.92 FEET TO THE POINT OF BEGINNING;
