

**ORDINANCE NO. 2014-08-\_\_\_**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF  
McKINNEY, TEXAS, AUTHORIZING A CERTAIN BUDGET  
AMENDMENT PERTAINING TO THE FISCAL YEAR 2013-2014  
BUDGET AND THE 2014 - 2018 CAPITAL IMPROVEMENTS  
PROGRAM; AND PROVIDING FOR AN EFFECTIVE DATE HEREOF**

**WHEREAS**, as required by the City Charter, the Interim City Manager has prepared an amendment to certain appropriations and expenditures / expenses in the 2013-2014 Budget and the 2014 - 2018 Capital Improvements Program and submitted same to the City Council for its approval and a true and correct copy is attached.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF  
McKINNEY, TEXAS, THAT:**

- Section 1. Pursuant to the City Charter requirements of the City of McKinney, Texas, in the Fiscal Year 2013 - 2014 Budget Amendment as attached is hereby authorized and approved.
- Section 2. The budget shall be amended by transferring \$4,755 from the Parkland/Median Fee Fund (Median Escrow from Zone I \$3,285 and Median Escrow from Zone J \$1,470) to the Park Construction Fund and to set up a new CIP project PK4370 Hardin Boulevard Median Improvements.
- Section 3. The budget for the Hardin Boulevard Median Improvements (PK4370) shall be amended by appropriating \$4,755 in the Park Construction Fund.
- Section 4. This Ordinance shall become effective from and after its adoption and is so ordained.

**Summary:**
