

# Economic Development Highlights Interim President Liu March 2016

#### Administration

- Staff met with Senior Financial Analyst, Trevor Minyard; Financial Services Business Coordinator, Xochilt Medina, and Economic Development Coordinator, Madison Clark to discuss the annual EDC State Report required by the Texas Comptroller's office each year. This report is compiled and reported to legislators and taxpayers to inform them how Type A and Type B Corporations are using tax dollars to support economic development in Texas cities. Both FY 2013-2014 and FY 2014-2015 reports were filed on March 1.
- Executive Assistant Van Slycke has been diligently working with city staff and legal counsel regarding additional questions on Open Records Request #15-017979 with requests about particular projects.
- Staff met with Paul Scheuren, Impact DataSource principal, to discuss the Impact Report for the projects. Scheuren will attend the March 15 MEDC Board Meeting to provide insights to the Board regarding the methodology of the report.
- IT staff has ordered and received all the necessary equipment to improve MEDC Board Audio/Visual devices. IT staff will bring out the projector next week to test it before scheduling the installation in late March.
- MEDC Special Board Meeting was held on March 1.

### Marketing/Networking

- Staff and Economic Development Coordinator, Madison Clark, have been working with Communications staff to develop a new design for MEDC promotional materials and advertising. MEDC placed a full-page inside front cover at Dallas Regional Chamber's "2016 Dallas Economic Development Guide".
- Staff attended the 2016 McKinney Community Awards Celebration hosted by the McKinney Chamber of Commerce on February 19. There were twenty-six attendees at MEDC tables including Chairman Lance Lindsay, Vice-Chairman Robbie Clark, Board Member Sheila Johnson, and Board Member Kenneth Sipiora, MEDC staff, Wistron executives from overseas and StatLab Chief Financial Officer.
