

**RESOLUTION NO. 2018-10-\_\_\_ (R)**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, APPROVING QUALIFIED FIRMS TO PROVIDE PROFESSIONAL SERVICES FOR ON-CALL ROADWAY DESIGN SERVICES AND ON-CALL UTILITY DESIGN SERVICES**

**WHEREAS**, the City Council of the City of McKinney, Texas, approved a process to choose professional service providers; and

**WHEREAS**, the City of McKinney utilizes consultants to provide professional services related to on-call roadway design services; and

**WHEREAS**, the City of McKinney utilizes consultants to provide professional services for on-call utility design services; and

**WHEREAS**, a request for qualifications was issued for on-call roadway design services (18-45RFQ) and on-call utility design services (18-46RFQ), and a pool of firms has been qualified based on the submitted statements of qualifications.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**
