## **RESOLUTION NO. 2015-12-\_\_\_ (R)**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, AUTHORIZING THE INTERIM CITY MANAGER TO EXECUTE CONTRACT AMENDMENTS WITH BRINKLEY SARGENT WIGINTON ARCHITECTS (BSW) OF DALLAS, TEXAS FOR ARCHITECTURAL AND ENGINEERING SERVICES RELATED TO THE DESIGN AND CONSTRUCTION OF PHASE 2 OF THE AQUATICS AND FITNESS CENTER LOCATED AT GABE NESBITT COMMUNITY PARK

- WHEREAS, the City Council of the City of McKinney, Texas, has determined the need for professional architectural and engineering (A/E) services related to the design and construction of the Aquatics and Fitness Center located at Gabe Nesbitt Community Park; and,
- WHEREAS, the City Council previously approved a contract with Brinkley Sargent Architects for full architectural and engineering services on February 17, 2014; and,
- WHEREAS, Brinkley Sargent Wiginton Architects (formerly Brinkley Sargent Architects), has submitted proposals for \$93,250 for the Phase 2 additional services requested by the City for this project.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

- Section 1. The City Council hereby authorizes the Interim City Manager to accept the proposals in the amount of \$93,250 and execute necessary change orders with BSW related to the design and construction of Phase 2 of the Aquatics and Fitness Center and related improvements, for a total contract amendment amount not to exceed \$93,250.
- Section 2. The A/E contract shall be increased to an amount that includes such change orders as they are executed by the Interim City Manager.
- Section 3. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
