

ORDINANCE NO. 2019-06-___

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS AMENDING SECTION 62-117 OF THE CODE OF ORDINANCES TO REVISE SPEED ZONES ON AIRPORT DRIVE FROM UNIVERSITY DRIVE (US 380) TO OLD MILL ROAD; TO REVISE THE LIMITS OF THE SPEED ZONE ON HARRY MCKILLOP BOULEVARD; AND TO REVISE THE LIMITS OF THE SPEED ZONE ON FM 546 IN MCKINNEY, TEXAS; AMENDING THE CODE OF ORDINANCES, CITY OF MCKINNEY, TEXAS; PROVIDING FOR PUBLICATION OF THE CAPTION OF THE ORDINANCE, EFFECTIVE DATE HEREOF AND A PENALTY CLAUSE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

Section 1. The City Council of the City of McKinney, Texas hereby amends Section 62–117 of the Code of Ordinances by modifying the following segment to read as follows:

Airport Drive, Zone 1, which extends from University Drive to Harry McKillop Boulevard, a speed limit of 45 miles per hour.

Airport Drive, Zone 2, which extends from Harry McKillop Boulevard to Old Mill Road, a speed limit of 30 miles per hour.

Section 2. The City Council of the City of McKinney, Texas hereby amends Section 62–107 of the Code of Ordinances by modifying the following segment to read as follows:

(a) It shall be unlawful for any person to drive a vehicle at a speed greater than 45 miles per hour on Harry McKillop Boulevard from McDonald Street (SH 5) to Wattley Way.

(b) It shall be unlawful for any person to drive a vehicle at a speed greater than 55 miles per hour on FM 546 from Wattley Way to the east city limit.

Section 2. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, after all the necessary signs and markings have been installed, and it is accordingly so ordained.

Section 3. Any person who violates any provisions of this Ordinance shall be guilty of a misdemeanor and, upon conviction, shall be subject to a fine not to exceed two thousand dollars (\$2000).
