The Heritage Guild of Collin County owns and operates Heritage Village at Chestnut Square. Located on 2 blocks at Chestnut, Anthony, Davis & Hwy 5, Chestnut Square is home to 5 historic houses, including the oldest house in McKinney, a general store, the former Foote Baptist Church, the "Two Bit" Taylor Inn, the fabulous Dulaney House, and a reproduction of the Wilmeth one room Schoolhouse.









Project Summary

Total Estimated Expenses: \$46,250

Total Request: \$32,750 (71%)

- Dulaney House: Siding; Porch & ramps repair/replacement; Gutter repair/replace; Exterior Paint; possible structural evaluation & repairs
- Dulaney Cottage: Porch, window & ramp repairs; Gutter repair/replace; structural work and evaluation
- Chapel: Bell Tower repairs; Siding, windows, porch & ramps repairs/replacement; Exterior paint and possible structural evaluation
- 29% of this project will be executed largely through the use of in-kind labor to do gutters, siding & porch repairs.



Dulaney History

The c. 1873 Victorian was built by Dr. Joseph Dulaney on the corner of Chestnut and Anthony Streets in three sections. The two additions were never tied in at the foundation level, only with roofing and siding. We did substantial foundation work in 2016 on the south side, and now the other side is failing.

This structure was moved in 1915 by Dr. Dulaney's widow and her brother, to build the big house on the more prestigious corner location.



Dulaney History

The large Prairie style house on the corner was home to the 2nd generation Dulaney's their entire lives. Neither Joseph Field or Corrine Dulaney ever married, and lived in the house until the 1960's.

The 2 houses were scheduled for demolition, as the Collin County Courthouse was to be built on the adjacent property, when a group of ladies raised the funds to purchase them and hence, founded the Heritage Guild of Collin County & Chestnut Square.



Dulaney History

You might know that Joseph Dulaney, a pharmacist at Smith Drugs downtown, was also a well-known arborist, and donated a piece of the homestead to build a library on the northwest corner of Anthony and Chestnut Streets, most recently known as Annex B before its demolition in 2016.


The inside of the Dulaney House was renovated in 2017 with a \$175,000 award from MCDC. We could not fit the exterior work into that budget, and unfortunately have been unable to raise the funds to do so in the interim.




The Chapel at Chestnut Square

The 1908 Foote Baptist church building was moved from the edge of Stonebridge in 1993 to become The Chapel at **Chestnut Square. After the Foote Community was** incorporated into the city, the church (on Virginia Parkway) changed its name to Parkway **Baptist, and now The Parkway** Church, serving McKinney continuously since 1904.
