City Manager Jason Gray stated that he would negotiate with Collin County to see if there were any of the existing lease terms between Collin County and the City of McKinney regarding the use of MPAC that could be modified. MPAC Director David Taylor stated that the school would use their in service training days when there would be a special event. Mr. Taylor stated that the north entrance would be a shared entry with Imagine Schools and they would have customer service as well as volunteers monitoring the door. The School would pay the difference for utility costs from what was paid last year. Council unanimously approved the motion by Mayor Pro-Tem Huff, seconded by Council member Ussery, to table this item to the May 23, 2011 Special Meeting.
