Mr. Shelton update the Board on the 9-acre site of the old courthouse, plans are being developed that include retail, office and residential and additional parking. The upcoming bond election will have 7 referendums and one of those is the downtown parking garage.

Ms. Rosenthal updated the board on the Oktoberfest planning and budget. Tupps Brewery will be a sponsor with a donation of \$2000. The subcommittee is planning to have a "Taste of" tent and Tupps will also have a beer tent, the consumption area is increased to include the carnival area and plans are in place to move activity down the side streets to alleviate congestion around MPAC. Ms. Rosenthal is working to have pre-sale for tickets via event brite and also by Kroger. Marketplace at OKT will double in size and PSA is coming back as a sponsor for the kid's area. The board discussed. Ms. Rosenthal updated the board on the concerns expressed by the merchants at the business monthly meeting concerning scare on the square, the merchants would like more decorations, the board discussed. Ms. Rosenthal informed the board about planning for Home for the Holidays, not a lot yet but talking with a vendor about a laser show, more details will be presented at the next meeting.
