

### OWNERS CERTIFICATE

BEGINNING at an "x" cut found for corner in the northwest line of Henneman Way (an 80' R.O.W.), said point being the southwest corner of Lot 4R, Block A, Henneman—Stacy, an addition to the City of McKinney as recorded in Cabinet 2013, Page 165, Plat Records of Collin County, Texas;

THENCE S64°52'18"W, with the northwest line of Henneman Way, a distance of 407.54 feet to a capped 1/2" iron rod found for corner;

THENCE N25°07'42"W, leaving Henneman Way, a distance of 319.67 feet to a capped 1/2" iron rod found for corner;

THENCE N00°08'48"E, a distance of 339.97 feet to a capped 1/2" iron rod found for corner in the south line of Lot 1, Block A, McKinney Soccer Complex At Craig Ranch, an addition to the City of McKinney as recorded in Cabinet 2006, Page 842, Plat Records of Collin County, Texas;

THENCE S89°51'12"E, with the south line of said McKinney Soccer Complex at Craig Ranch, a distance of 498.70 feet to a capped 1/2" iron rod found for corner in the west line of the aforementioned Lot 4R, Block A, Henneman—Stacy addition;

THENCE S00°38'52"E, with the west line of said Henneman—Stacy addition, a distance of 455.07 feet to the POINT OF BEGINNING and CONTAINING 264,444 square feet, or 6.071 acres of land.

All and any public utility and the City of McKinney shall have the right to remove and keep removed all or parts of any buildings, fences, shrubs, trees, or other improvements or growths which in any way endanger or interfere with the construction, maintenance, or efficiency of its respect—tive systems on said easements, and the City of McKinney and all public utilities shall at all times have the right of ingress and egress to and from and upon the said easement strips for the purpose of constructing, reconstructing, inspecting, patrolling, maintaining and adding to or removing all or parts of its respective systems without the necessity, at any time, of procuring the permission of anyone.
