

ORDINANCE NO. 2018-08-___

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS MODIFYING REDUCED SPEED SCHOOL ZONES, THE DESIGNATED SCHOOL CROSSWALKS, AND PARKING REGULATIONS FOR FAUBION MIDDLE SCHOOL IN MCKINNEY, TEXAS; AMENDING THE CODE OF ORDINANCES, CITY OF MCKINNEY, TEXAS; PROVIDING FOR PUBLICATION OF THE CAPTION OF THE ORDINANCE, EFFECTIVE DATE HEREOF AND A PENALTY CLAUSE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

Section 1. The City Council of the City of McKinney, Texas hereby amends Section 62-228 of the Code of Ordinances to read as follows:

Sec 62-228. Faubion Middle School – Zone Designated.

The Faubion Middle School zone shall be:

- (1) On Hollis Street beginning at Doe Rollins Street and extending northward along Hollis Street to a point 200 feet north of Camellia Lane.
- (2) On Doe Rollins Street beginning at Hollis Street and extending eastward along Doe Rollins Street to Duvall Street.
- (3) On Duvall Street beginning at a point 175 feet north of Josephine Street extending southward along Duvall Street to Doe Rollins Street.
- (4) On Paula Road beginning at a point 100 feet south of Doe Rollins Street and extending northward along Paula Street to Doe Rollins Street.
- (5) On Isola Road beginning at a point 100 feet south of Doe Rollins Street and extending northward along Isola Road to Doe Rollins Street.

Section 2. The City Council of the City of McKinney, Texas hereby amends 62-230 which will read as follows:

Sec 62-230. - Same – Crosswalks.

Crosswalks shall be established at the Faubion Middle School as follows:

- (1) On Doe Rollins Street at a mid-block location, 250 feet east of Paula Road.

Section 3. The City Council of the City of McKinney, Texas hereby repeals Section 62-231 and Section 62-232 of the Code of Ordinances.

Section 4. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, after all the necessary signs and markings have been installed, and it is accordingly so ordained.

Section 5. Any person who violates any provisions of this Ordinance shall be guilty of a misdemeanor and, upon conviction, shall be subject to a fine not to exceed two thousand dollars (\$2000).
