A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH THE TEXAS COMPTROLLER OF PUBLIC ACCOUNTS TO RECEIVE A \$322,253.68 DISTRIBUTED RENEWABLE ENERGY PROGRAM GRANT FOR A SOLAR ARRAY FOR FIRE STATION #6

- WHEREAS, the City Council of the City of McKinney, Texas, recognizes the importance of reducing its energy consumption and thereby reducing not only its expenses but also its carbon footprint, and
- **WHEREAS**, the solar array will provide almost have of the energy demand for Fire Station #6,
- **WHEREAS**, the City Council understands that Collin County is in the Dallas-Fort Worth non-attainment area for ozone, an impediment to economic development and a health risk for its citizens, and
- **WHEREAS,** by reducing the City's energy demands, the City also reduces the emissions that produce ozone, and
- **WHEREAS,** by using renewable energy sources such as solar panels, the City secures the ability to provide energy from a free fuel source the sun for several decades,
- **WHEREAS,** by securing this grant the City is able to construct a \$386,704.41 solar array with only \$9,421.63 of city funds for Fire Station #6,

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

- Section 1. The City Council of the City of McKinney, Texas, hereby accepts the contract with the Texas Comptroller of Public Accounts for a \$322,253.68 Distributed Renewable Energy Program Grant.
- Section 2. The City Manager is authorized to execute the contract with the Texas Comptroller of Public Accounts for a \$322,253.68 Distributed Renewable Energy Program Grant.
- Section 3. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
