The Reinvestment Zone Number Two of the City of McKinney, Texas met in regular session in the Council Chambers, 222 N. Tennessee Street, McKinney, Texas on August 20, 2013 at 5:00 p.m.

Year 2013-2014 Annual Budget for Tax Increment Reinvestment Zone
Number Two (TIRZ No. 2 / Airport TIRZ). Chief Financial Officer Rodney
Rhoades presented the fiscal year 2014 budget. He stated that property
taxes account for \$18,235 which is a reduction from prior years. Staff
has been somewhat conservative on sales tax again this year in
anticipation of a better year than what was originally budgeted for FY13.

Mr. Rhoades stated they have allocated a small contingency for smaller
projects that might come before the board during the year. He stated

\$312,000. Board member Day requested that in the future he would like

would call for a fiscal year reporting period (October 1 - September 30)

rather than a calendar year period. The change would allow reported

revenues and expenditures to better match the City's financial reports

and more accurately reflect the sales tax revenues. Board members

by Board member Day, to change to the annual reporting period from a

calendar year to coincide with the City of McKinney's fiscal year for the

Tax Increment Reinvestment Zone Number Two (TIRZ No. 2 / Airport

TIRZ).

Board members unanimously approved the motion by Board member

Loughmiller, seconded by Board member Kever, to adjourn. Chairman Ussery

adjourned the meeting at 5:10 p.m.
