As a resident of McKinney (809 Kiowa Dr), I have heard bits and pieces throughout the community of a proposal to set aside some land in the McKinney Ranch area for the construction of a multi-purpose facility that would include a state-of-the-art football stadium for use by all schools in the McKinney area. This idea intrigues me, and I am in great support of this proposal, provided that the majority of the funding would come from the raising of municipal bond funds and not our property tax dollars.
