### CITY COUNCIL REGULAR MEETING

#### **FEBRUARY 21, 2012**

The City Council of the City of McKinney, Texas met in regular session in the Council Chambers of the Municipal Building on February 21, 2012 at 6:00 p.m.

**11-141PR2** Mayor Loughmiller called for Public Hearing for Consideration/Discussion/Action on the Request by Rockbrook Development, L.L.C., for Approval of a Preliminary-Final Replat for Lots 1-4, Block A, of the Rose Addition, Approximately 0.16 Acres, Located on the Northeast Corner of Tennessee Street and Walnut Street. Senior Planner Michael Quint stated that this item was tabled from the February 7, 2012 meeting. Mr. Quint stated that the Engineering staff has met with the applicant and both parties have agreed to several concessions that will better address the storm water detention on the property. The Engineering staff is comfortable that the intent of the Ordinance has been addressed and is supporting a variance to Section 142-105 of the Subdivision Ordinance reducing applicable storm water detention requirements. Mr. Quint stated that the only variance that Staff is not comfortable supporting is relating to the parkland dedication requirement. Mr. Quint stated that Staff recommends approval of the proposed preliminary-final replat granting variances outlined in the staff report. Mr. Quint clarified that in the agenda item it stated that the City would be donating \$2,000 towards the construction of a man hole. The Developer will be reimbursing the City for the \$2,000. Applicant, Mr. Jason Rose, stated that he was available for questions and there were none. Council unanimously approved the motion by Mayor Pro-Tem Ussery, seconded by Council member Kever, to close the public hearing and approve a Preliminary-Final Replat for Lots 1-4, Block A, of the Rose Addition, approximately 0.16 acres, located on the northeast corner of Tennessee

Street and Walnut Street with the following conditions: The applicant satisfy the conditions as shown on the Standard Conditions for Preliminary-Final Replat Approval Checklist; the applicant receive approval of a variance to Section 142-105 of the Subdivision Ordinance waiving the requirement to construct portions of Walnut Street located adjacent to the subject property; the applicant receive approval of a variance to Section 142-105 of the Subdivision Ordinance reducing applicable storm water detention requirements; prior to filing the plat for record: the applicant revise the plat to provide a notation indicating that the proposed common area will be owned and maintained by a homeowners' association; the applicant revise the plat by labeling Common Area A-1 as a drainage easement; and the applicant receive approval of a variance to Section 142-157 of the Subdivision Ordinance waiving the requirement to dedicate park land or pay cash in lieu of a park land dedication.

11-153M3

Mayor Loughmiller called for Consideration/Discussion/Action on a Resolution Defining Truck Fueling Station and Truck Stop and Establishing which Zoning District(s) are Appropriate for these New and Senior Planner Jennifer Cox stated that this Unlisted Land Uses. Resolution would define a truck fueling station and truck stop and would establish where those uses would be appropriate within the City of McKinney. Ms. Cox stated that Staff is not proposing that a Truck Stop be allowed anywhere within the city limits of McKinney. Council member Day stated that a fueling station does not allow for scales and that scales are an important part of how they operate. Mayor Loughmiller stated that he likes the Resolution that was presented and stated that one of his concerns is that if semi-trailers are waiting to get fuel and scales are in place, would it then become a weighing station that would create a stacking issue. Ms. Cox stated that no more than one vehicle would be allowed to wait for another vehicle to finish fueling. She stated that the

definition could be modified to say stacking for no more than 2 vehicles. City Manager Jason Gray stated that from an enforcement standpoint, this gives the City the tool for enforcement should we run into a consistent issue. Council member Brooks stated that he agrees with Mayor's comments that stacking is a real concern and needs to be addressed. Council member Day stated that he has no objection to limiting the stacking as long as they have the scales. Ms. Cox restated the Council's suggestions to the following: to allow in industrial zoning districts, modify the definition of a fueling station, include scales, specify a single point of fueling per vehicle, and to not allow stacking with a Specific Use Permit required. Council unanimously approved the motion by Council member Brooks, seconded by Council member Harris, to approve the Resolution Defining Truck Fueling Station and Truck Stop and Establishing which Zoning District(s) are Appropriate for these New and Unlisted Land Uses to read as follows: the new and unlisted use identified as a "Truck Fueling Station" is hereby defined to be and mean "a retail fuel sales facility selling fuel for motor vehicles and semi-trailer trucks with at least 3 axles that are designed to tow trailers, limited to no more than one fueling pump per semi-trailer truck fueling bay. The truck fueling station may be attended or automated and include accessory truck scales/weigh stations. Off-site stacking for fueling and weighing purposes shall be prohibited; a "Truck Fueling Station" shall be permitted subject to approval of a specific use permit within the "ML" - Light Manufacturing and "MH" - Heavy Manufacturing zoning districts within the City of McKinney; the new and unlisted use identified as a "Truck Stop" is hereby defined to be and mean "any premises that provides parking facilities for semi-trailer trucks with at least 3 axles that are designed to tow trailers in conjunction with one or more other uses including, but not limited to, the incidental sale of accessories or equipment for such vehicles, fuel sales, truck scales/weigh stations,

restroom and showering facilities, restaurant facilities, truck washing facilities, and/or other uses typically associated with semi-trailer truck resting areas; and that a "Truck Stop" shall be prohibited in all zoning districts within the City of McKinney. Caption reads as follows:

11-154M3 Public Mayor Loughmiller called for Hearing for а Consideration/Discussion/Action on the Request by the City of McKinney, for Approval of the Request to Amend Chapter 146 - Zoning Regulations of the Code of Ordinances, to Modify the Definitions of Car Wash, Fueling Station or Gasoline Station, and Service Station, and Accompanying Ordinance. Planning Director Jennifer Cox stated that staff is proposing to modify the definitions of car wash, fueling station or gasoline station, and service station as found in Section 146-46 (Definitions) of the City of McKinney Zoning Regulations to clearly identify the types of vehicles permitted within each definition. The current definitions for car wash, fueling station or gasoline station, and service station should be modified in an effort to remove any uncertainty with regard to permitted/prohibited vehicle types. Mayor Loughmiller called for public comment and there were none. Council unanimously approved the motion by Mayor Pro-Tem Ussery, seconded by Council member Brooks, to close the public hearing and approve the Ordinance amending Chapter 146 - Zoning Regulations of the Code of Ordinances, to Modify the Definitions of Car Wash, Fueling Station or Gasoline Station, and Service Station, to read as follows: "(22) Car wash means a building or portion thereof, containing facilities for washing motor vehicles including,

but not limited to, automobiles, motorcycles, buses, or recreational

vehicles (excluding semi-trailer trucks with at least 3 axles that are designed to tow trailers) using automated or manual methods including chain conveyor, blower, steam cleaning device, or other mechanical device. A car wash may also be referred to as an auto laundry;" "(47) Fueling station or gasoline station means a retail fuel sales facility selling fuel for motor vehicles including, but not limited to, automobiles, motorcycles, buses, or recreational vehicles (excluding semi-trailer trucks with at least 3 axles that are designed to tow trailers) with no ancillary services such as vehicle service, vehicle repair, or sale of items other than fuel. The fueling or gasoline station may be attended or automated;" and "(98) Service station means any building or premises used for the dispensing, sale, or offering for retail sale of any fuels or oils for motor vehicles including, but not limited to, automobiles, motorcycles, buses, or recreational vehicles (excluding semi-trailer trucks with at least 3 axles that are designed to tow trailers). If the dispensing, sale or offering for sale is incidental to a public garage, the premises shall be classified as a public garage, and not as a service station." Caption reads as follows:

Mayor Loughmiller called for Council and Manager Comments

Council member Ricchi did not have any comments.

Council member Day did not have any comments.

Council member Kever thanked all the business and individuals that won awards and the Chambers Award Banquet last Friday night. She stated that she attended a Women of Service luncheon and appreciated the fact that they got the opportunity to get together. Ms. Kever stated that she had several individuals that are forming a non-profit

community garden and stated that they will contact the City to discuss a location. She stated that she understood that there are some people for and against the sustainability plan and that this is a good way for everyone to come together.

Council member Harris stated that the Chamber of Commerce event was very well done and a lot of people contributed. He thanked the Mayor, Mayor Pro-Tem, City Manager, the airport staff and McKinney Airport Development Corporation Chairman John Wroten for the time they spent in Washington, DC speaking to Congressional and Senate members. The visit was well received and the City of McKinney is viewed higher as a result of their visit. Mr. Harris thanked Staff for all their work putting together the agenda items that are presented to Council.

Council member Brooks stated that the Chamber event was very well done and he appreciated it being in held at the McKinney airport. He stated that City Council was invited to read at Minshew Elementary for National Literacy Day on March 2nd and he asked his colleagues to attend with him.

Mayor Pro-Tem Ussery thanked Staff for all they do, day in and day out and gave special recognition to the Finance Department. He recognized the Citizen of the Year, Mr. James C. Stewart. His passing was an unfortunate loss for McKinney, his greatness will live on through the people that he positively touched and we should all work in a positive way as he did.

Mayor Loughmiller stated that the Washington D.C. trip was a very good trip for the City of McKinney and he appreciated Chairman of the Airport Board, Ken Wiegend, Mayor Pro-Tem Ussery, Council member Harris and City Manager Gray for attending. He stated that they met with 16 people in a 24 hour period from the FAA, Compliance, Funding, and Tower Organizations. He stated that they spoke with Congressmen Sam Johnson and Ralph Hall, Senators Hutchinson and Cronyn about the airport as well as Lake Texoma issues. Mayor stated he wants to let everyone know that because there is no "sustainability plan" does not mean that the city does not have plans. He stated that there are plans such as a 20 year Master Park Plan, Storm Water Drainage Plan, Zoning Plan, multiple Long Range Plans in the city already in place that address things such as tree mitigations when a development occurs and stated that the City of
