A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, AUTHORIZING THE INTERIM CITY MANAGER TO EXECUTE A MEMORANDUM OF UNDERSTANDING WITH THE SUNSHINE ROTARY CLUB ALLOWING FOR THE DESIGN AND CONSTRUCTION OF AN ALLINCLUSIVE PLAYGROUND AT BONNIE WENK PARK.

- **WHEREAS,** the City of McKinney, Texas ("City"), is interested in promoting public / private partnerships for the betterment of the community; and
- **WHEREAS,** Public / private partnerships are a great opportunity to leverage use of valuable city resources; and
- **WHEREAS,** Public / private partnerships allow for developments to occur on a shared cost basis; and
- **WHEREAS,** Public / private partnerships promote a sense of community and provide a means for collaboration between various entities; and
- WHEREAS, the Sunshine Rotary Club requested the City consider a private / public partnership for the purpose of developing an All-Inclusive playground at Bonnie Wenk Park; and
- WHEREAS, Bonnie Wenk Park Phase II is currently in design; and
- **WHEREAS**, addition of the All-Inclusive playground to Bonnie Wenk Ph. II can easily be achieved at little or no additional cost to the City; and
- **WHEREAS,** the City has approved the use of Bonnie Wenk park as the best location for the proposed All-Inclusive playground; and
- **WHEREAS,** the City would like to enter into a Memorandum of Understanding allowing formation of the Public / Private partnership between the City and Sunrise Rotary Club.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

- Section 1. The City Council of the City of McKinney, Texas, hereby supports the formation of a public / private partnership between the City and Sunrise Rotary Club.
- Section 2. The Interim City Manager is hereby authorized to execute a Memorandum of Understanding with the Sunrise Rotary Club allowing for the design and construction of an All-Inclusive Playground at Bonnie Wenk Park.
- Section 3. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
