Dear Cindy and Board of Directors,

Habitat for Humanity of Collin County would respectfully request an extension of three (3) months through April 30th, 2020 for the project grant 18-06 in the total amount of \$877,521. This request is due to unforeseen delays in infrastructure with sewer/water in conjunction with City CIP project requiring additional casement pipe for boring for water. The current expiration is January 31st, 2020.

This delay in utilities will delay the retaining wall and final completion of paving beyond the Jan 31st deadline in our current contract.

We are currently 92% complete with only \$80,601 remaining of the total \$877,521.
